<p>1. BEPALINGS</p> <p>Die huidige keurbeleid kan soos volg opgesom word:</p> <p>(i) Enige kandidaat kan om toelating tot die eerste jaar van die volgende kwalifikasies aansoek doen: BSc Fisioterapie en B Arbeidsterapie, (d.w.s. matrikulante, skoolverlaters, graduandi en diplomandi, asook diegene wat reeds vir 'n graad ingeskryf is).</p> <p>(ii) 'n Holistiese benadering is belangrik in die keuringsproses, wat op 'n puntesistiem gebaseer is wat akademiese prestasie, Nasionale Normtoets (NNT), kulturele aktiwiteite en sport insluit.</p> <p>(iii) 'n Besliste poging word aangewend om kandidate met 'n agtergeblewe akademiese agtergrond met die nodige potensiaal en 'n redelike vermoë om sukses in hul kursus te behaal te akkommodeer, en om te streef daarna om sensitief te wees tenoor geslagsverdeling tydens keuring.</p> <p>(iv) Daar word hoofsaaklik Suid-Afrikaanse studente gekeur vir studies in die Gesondheidswetenskappe, as gevolg van die hoë koste verbonde aan die opleiding van studente. Studente wat by die Skool vir Aanvullende Gesondheidsberoepes ingeskryf is, is uitgesluit van die Departement van Gesondheid se beleidsooreenkoms.</p>	<p>1. PREMISES</p> <p>The present selection policy can be summarised as follows:</p> <p>(i) Any candidate may apply for admission to the first year of the following qualifications: BSc Physiotherapy and B Occupational Therapy, (i.e. matriculants, school leavers, graduates and diplomates, as well as persons already studying for a degree).</p> <p>(ii) A holistic approach is important in the selection process, which is based on a points system that includes academic achievement, National Benchmark Test (NBT), cultural activities and sport.</p> <p>(iii) A definite effort is made to accommodate applicants from a disadvantaged educational background who display the necessary potential and a reasonable ability to attain success in their course, and to strive to be sensitive towards gender distribution in selection.</p> <p>(iv) Mainly South African students are selected for studies in Health Sciences due to the high costs involved in the training of students. Students enrolled in the School for Allied Health Professions are excluded from the Department of Health's policy agreement.</p>

2. ANDER VEREISTES

(i) 'n Geneeskundige verslag wat deur 'n mediese praktisyn voltooi moet word, sowel as die voltooiing van 'n gesondheidsvraelys, word van studente vereis.

(ii) Immuniseringsvereistes

Die Fakulteit behou hom die reg voor om volgens eie diskresie van tyd tot tyd verdere immunisering teen siektetoestande te vereis, voordat die student tot enige akademiese jaar of semester gedurende sy/haar studies toegelaat kan word. Wat die kwalifikasies Fisioterapie, Arbeidsterapie, Dieetkunde en Optometrie aanbetref, sal immunisering teen Hepatitis B tydens opleiding plaasvind en is dit dus nie nodig dat die student vooraf immunisering ondergaan nie.

Die Skool vir Aanvullende Gesondheidsberoepes volg die riglyne vir immunisering soos vervat in die nuutste goedgekeurde amptelike beleidsdokument. Die volledige beleidsdokument is beskikbaar by Voorgraadse Studente-Administrasie, Fakulteit Gesondheidswetenskappe.

(iii) MIV-status

Die Fakulteitsbestuur wil namens die Fakulteit Gesondheidswetenskappe elke student graag inlig dat, indien sy/haar MIV-status positief is, hy/sy voordat hy/sy die gekeurde plek inneem, daarvan bewus moet wees dat hy/sy blootgestel gaan word aan pasiënte met infektiewe siektes, wat 'n invloed op sy/haar fisiese toestand of status kan hê. In so 'n geval sal hy/sy dan die verantwoordelikheid moet aanvaar om voorsorgmaatreëls te tref sodat hy/sy nie siek word weens sy/haar positiewe status en blootstelling nie. Daar sal van alle

2. OTHER REQUIREMENTS

(i) A medical report to be completed by a medical practitioner, as well as the completion of a health questionnaire, are required from students.

(ii) Immunisation requirements

The Faculty reserves the right to require further immunisation against illnesses at own discretion, before the student may be allowed to any academic year or semester during the course of his/her studies. Regarding the qualifications Physiotherapy, Occupational Therapy, Dietetics and Optometry, immunisation against Hepatitis B will take place during training and it is thus not necessary for the student to be immunised beforehand.

The School for Allied Health Professions follows the guidelines for immunisation as contained in the latest approved official policy document. The complete policy document is available from Undergraduate Student Administration, Faculty of Health Sciences.

(iii) HIV status

On behalf of the Faculty of Health Sciences the Faculty Management wishes to inform each student that, should his/her HIV status be positive, he/she should be aware before he/she takes up his/her selected position, that he/she will be exposed to patients with infective diseases, which could have an influence on his/her physical condition or status. In such cases, he/she will then be responsible for taking precautionary measures so that he/she does not become ill due to his/her positive status and exposure. It will be expected of all
