

It opened its doors in Bloemfontein in **1904** as the Grey University College, with six students in the Humanities. DEVELOPMENT OF THE UFS CREST OVER MORE THAN A CENTURY

1904

Up to 1935, the same coat of arms was used as the Grey College School.





By 1935, with the name change to University College of the Orange Free State, the coat of arms fell into disuse, especially among students.

1947

In 1947, an agreement between management and students led to the new motto Per Fidem ad Sapientiam (Through faith to wisdom).

1950

In 1952, it was changed to In Deo Sapientiae Lux (In God is the light of wisdom). The traditional orange, white and blue, linking the UFS to the South African national colours, changed in the late 1990s.

The orange was replaced by cherry red.

The academic brand - the historic University of the Free State crest that has been the symbol of the university since 1952, has evolved to embrace the aesthetic expectations of the stakeholders. The shape of the traditional academic shield has been simplified and contemporised. Much of the symbolism of the crest remains intact, acknowledging the location of the UFS brand as one of the country's premier institutions of higher education, with a proud history of academic excellence and an ever evolving, vibrant culture.





Janie Swanepoel received her secondary education in Bloemfontein and her BA at the University of Stellenbosch and her BA Honours in Social Anthropology at the University of Cape Town before obtaining in 2013 her MA in Social Anthropology (with distinction) at Stellenbosch. She successfully submitted her PhD dissertation in Social Anthropology at the University of the Free State in 2020. Her PhD forms part of a co-tutelage agreement with the University of Cologne and both universities will award her the degree. She currently works in Social Compliance and has been invited to rework her dissertation into a book.

With her thesis, titled: **IN THE LAND OF THE JACKALS: POSTCOLONIAL ARIDITY IN SOUTHERN NAMIBIA**, the candidate analyses multispecies relations in a changing Namibian Boer community and argues that the future of arid-land farming depends on recognising the living histories of human-animal relations and its entanglement with social capital in ranching as it currently exists. Transcending diverse disciplines the dissertation shows how human-animal relations are deeply integrated into the doing and undoing of (post)colonialism in rural southern Africa. It demonstrates how jackals, sheep and Boers continue to shape whiteness in dealing with the unpredictable quotidian exigencies of surviving a harsh and unpredictable environment. Given the glocal increase in aridity, this dissertation shows the limitations of engaging with the decolonisation of land and the impact of climate change in ways that perpetuate the binary between nature and culture and suggests the need to rethink the current paradigm of commercial ranching in rural southern Africa.

With her thesis, titled: BATTLES OVER BOUNDARIES AND BELONGING: VIOLENCE, WILDERNESS AND SPATIAL RECONFIGURATIONS IN THE CONVERSION OF FARM LANDSCAPES IN KWAZULU-NATAL, the candidate investigates the socio-political and spatial dynamics of conversions of farms to wilderness landscapes and game farms in the KwaZulu-Natal Province in South Africa. The study takes the theoretical position that 'nature' and 'wilderness' are social constructs rather than realities with single definitions. The empirical material was generated through ethnographic fieldwork on privately owned farms in the borderlands of former Natal and KwaZulu, and research carried out at a provincial heritage conservation park in north-eastern KwaZulu-Natal. Highlighting the ground-level politics of land issues, the thesis argues that local narratives and contexts should not be obscured by national processes of land politics, or by global trends in nature conservation; as this will not only leave past injustices unresolved, it will also bring them into the future.

DOCTOR OF PHILOSOPHY IN FINE ARTS

VON MALTITZ, Adelheid Camilla

Adelheid von Maltitz has been the Academic Head of the Fine Arts department since 2019. In 2017 she received the Runner-Up Award, Sasol New Signatures Top 100: discovering South Africa's emerging artists, and she was a finalist in the Barclays l'Atelier Top 100: art needs you, award in 2014, 2015 and 2017. In 2014 she was invited to participate in the South Africa: 10 by 12 @ SA, Contemporary Artists from South Africa, Benetton Foundation exhibition at Museo Bilotti, Rome, Italy. In 2021 she won one of the three Absa L'Atelier Ambassador awards, among entrants from twelve countries.

With her thesis, titled: **ART, PLACE, DEATH: THE TRANSFORMATIVE POWER OF DYNAMIC THRESHOLDS,** through an art exhibition and a thesis, the candidate investigates the extent to which art practice can enable constructive and healing engagement with questions of death, trauma and loss. She focuses specifically on the properties of site, ritual and materiality, and the extent to which they enable the transformative bridging of 'dynamic thresholds' between life and death, materiality and immateriality, the real and the ineffable. Her interdisciplinary approach draws on her own, as well as on historical and contemporary art, research on roadside and other spontaneous shrines, on cemeteries and monuments, as well as mourning and funerary practices in death studies. One examiner commends the elegant, clear and concise way in which she interweaves personal, critical and theoretical perspectives. Another concludes: "In the end, her thorough investigation of a comprehensive frame of reference promotes such informed access to her work that one cannot but be astounded by its underlying thought processes and acumen".

DOCTOR OF PHILOSOPHY IN MUSIC

GERBER-VENTER, Melissa

Melissa Gerber was born in Pretoria. After matriculating from Hoërskool Zwartkop in 2008, she obtained the degrees Bachelor of Music in Performing Art cum laude in 2012, and Master of Music in Performing Art (with distinction), both from the University

of Pretoria. Melissa also holds a Graduate Diploma in Vocal Performance from the Royal College of Music in London, awarded in 2015. She will take up a position as postdoctoral research fellow with the SARChI Chair in Art and Visual Culture at the University of Johannesburg in January 2022.

THE HUMANITIES

With her thesis, titled: (DE) CODING CONTEMPORARY SOUTH AFRICAN OPERA: MULTIMODALITY AND THE CREATION OF MEANING, 2010-2018, the candidate uncovers the multitude of, and relationships between, semiotic elements influencing the reception of opera production. She outlines opera's multimodal network and illustrates its intricacies by focusing on a select set of relationships across categories, applying strategies of close reading to three contemporary South African opera productions - Saartjie (2009), Poskantoor (2014) and Mandela Trilogy (2011/2014). Her thesis moves away from previously dominant score-based insights and highlights previously neglected visual modes of South African opera production. By employing recorded production media as an analytic source, and paying specific attention to the genre's paratextual networks, she investigates the ways in which different modes converge to influence reception. The research shows that South African opera production is encoded with layers of meaning extending beyond the genre's musical mode, paving the way for new avenues of inquiry in the field.

DOCTOR OF PHILOSOPHY IN PSYCHOLOGY

MAKHELE, Lerato

Lerato Mmusi-Makhele was born in Bloemfontein on 10 July 1978. She received her secondary education at Brebner High School where she matriculated in 1995. She obtained a BSc degree in 2001, an Honours degree in Behavioural Genetics in 2002, an Honours degree in Psychology in 2003 and an MSc Degree in Clinical Psychology in 2005. In 2007, she was appointed as a Clinical Psychologist at Student Counselling and Development at the University of the Free State. She is currently employed as Senior Clinical Psychologist at the Free State Psychiatric Complex and Senior Lecturer in the Department of Psychiatry (UFS).

With her thesis, titled: **THE DESIGN, IMPLEMENTATION AND EVALUATION OF AN HIV COUNSELLING SKILLS PROGRAMME FOR LAY COUNSELLORS**, the promovendus makes a valuable contribution to the field of HIV counselling within the public healthcare sector. There is limited research focusing on skill development of lay counsellors within the HIV field. With this contribution, she attempts to determine the impact of an HIV counselling skills training programme on the counselling skills, competence and management of burnout among lay counsellors. The findings identified several gaps in the execution of HIV counselling within HIV Testing Services (HCT) services. Furthermore, the study revealed systemic and workrelated indicators that influence the HIV counselling provided by lay counsellors. Further counselling training that incorporates systemic variables, service users, regular supervision and on-going training as standard practice is recommended. Additionally, the study identified the need to reorganise recruitment practices to enable quality employment opportunities that promote the selection of suitable candidates as lay counsellors.

MBHELE, Phindile Ellina

Phindile Ellina Mbhele was born on the 30th November 1977 in Newcastle, KZN. She matriculated from Thembalentsha High school (1997). Having obtained first position at her school she was awarded a bursary to study at ML Sultan Technikon in



Hospitality Management. She joined the SANDF in 1999 and completed a Diploma in Hospitality Management in 2003. Having worked as Caterer in the Military the candidate began studying. In 2011 she completed a BSoc Sc (Cum Laude), 2012 Honors Psychology, and in 2015 Master's in Clinical Psychology (UFS). In 2011 she was also awarded best student in Sociology. Currently she holds a rank of Major in SANDF and has one publication to her name already.

With her thesis, titled: **COMBAT EXPOSURE AS MODERATOR BETWEEN RISK, PROTECTIVE FACTORS AND SUICIDE IDEATION FOR SOUTH AFRICAN INFANTRY ARMY SOLDIERS**, the candidate contributes to the scholarly as well as systemic understanding into how antecedent risk and protective factors moderated to combat exposure affect suicidal ideation within the active infantry soldier corps of the SANDF. A sample of 1475 soldiers from nine units across SA was researched to better understand the interaction between risk and protective factors, on suicide ideation in combatant and non-combatant members. Soldiers facing combat exposure categorised in the high risk group of suicide ideation thereby increasing participation in risk-behaviour thinking and actions. This vulnerability is considerably mitigated through the presence of tangible support (physically and emotionally) during and after combat exposure. Using a salutogenic approach within which to embed the interactions of risk and protective factors offered an inherently optimistic perspective from which military well-being was approached.

DOCTOR OF PHILOSOPHY WITH SPECIALISATION IN AFRICA STUDIES

BRON - SWART, Eleanor Janet

Eleanor Bron-Swart was born in Pretoria on 31 October 1989. She matriculated from Wonderboom Highschool in Pretoria in 2007. She obtained a Journalism degree in 2010 from the University of Pretoria. She then shifted her focus to the discipline of History, obtaining an Honours degree in 2011 and a Masters degree in 2, 2015 from the University of Pretoria, both with distinction. For her performance at Honours level she received an achievement award from van Schaik and the Historical Association of South Africa. As a part-time lecturer she has taught a variety of subjects at the universities where she studied.

With her thesis, titled: 'WITH DIVIDED MIND AND UNSURE STEPS': SOUTH AFRICA FROM REFERENDUM TO REPUBLIC, AUGUST 1960 – MAY 1961, the candidate has explored various understudied aspects of South Africa's transition to a republic. By focussing on voter motivation as expressed in mainstream Afrikaans and English-language newspapers, the candidate has made a contribution to scholarly understanding of the diverse opinions held by the electorate, as opposed to the monolithic interpretations usually asserted by politicians. This has contributed to the methodology of the discipline, by critically utilising newspapers as a means of gauging public opinion. By integrating white and black history at a crucial juncture in the recent past, the thesis reinterprets the political choices and social processes propelling South Africa into a prolonged struggle against white minority rule.

KOKE, Honest Elias

Honest Elias Koke was born on 9 November 1989 in Harare, Zimbabwe. He received his secondary education in Mhondoro Ngezi District, Mashonaland West Province. He obtained his first degree in Economic History at the University of Zimbabwe (UZ) in 2014 and his Masters in African Economic History three years later, also from UZ. He started his academic career as a Graduate Teaching Assistant at the University of Zimbabwe between August 2016 and August 2017, before joining the International Studies Group (ISG) for his doctoral studies in 2018.

With his thesis, titled: A HISTORY OF SOUTHERN RHODESIA'S FISCAL SYSTEM: THE POLITICAL ECONOMY OF REVENUE COLLECTION AND EXPENDITURE, 1890-1953, the candidate contributes to the scholarly understanding of

Southern Rhodesia's financial history. Based on a wide range of archival and secondary sources, the study traces the evolution of the colony's fiscal system initially under British South Africa Company (BSAC) rule and latterly during successive settler administrations once Responsible Government came into being in 1923. This examination of the fiscal dimension of Southern Rhodesian development not only encompasses all major economic activities and their evolution over time, but also explores the contested emergence of racialized inequalities.

SIBANDA, Geraldine Jacquline

Geraldine Jacquline Sibanda was born in Bulawayo, Zimbabwe on 29 November 1986. She received her secondary education in Zvishavane, Midlands at Dadaya High School in 2004. Sibanda graduated with a Bachelor of Arts Honours Degree in 2008 and a Master of Arts in African Economic History in 2017, both degrees were conferred by the University of Zimbabwe. She worked for the public and NGO sectors in Zimbabwe, between 2009 and 2018 where she occupied various posts including executive assistant to the Minister of Finance, consultant for the UNDP and World Bank and Teaching Assistant at the University of Zimbabwe.

With her thesis, titled: **FINANCE, ECONOMIC PLANNING AND POWER IN ZIMBABWE, 1980-2013,** the candidate contributes to literature examining the nature of the postcolonial regime and how the economy was structured to ensure its survival. Using predominantly qualitative research methods, Sibanda argues that an elite comprising high-ranking politicians, civil servants and members of international financial institutions, made major economic policy and state finance decisions at the expense of the public and Parliament, in a manner that kept the regime in power. The skewed budget structure that favoured the security sector and the increasingly oppressive regime notwithstanding, the elite burdened Zimbabwe with sovereign debt not in the best interests of the population, leading the candidate to make a compelling case for the notion of odious debt doctrine. She concludes that inherited international financial architecture and the power retention agenda were responsible for Zimbabwe's never-ending economic crises.

DOCTOR OF PHILOSOPHY WITH SPECIALISATION IN AFRIKAANS AND DUTCH

STANDER, Alison Gretchen

Alison Gretchen Stander was born on 30 September 1987 in Beaufort West, where she matriculated from Central High School. She completed a BA in Humanities (2008) and a Master's degree in Hypermedia for Language Learning (2011) at Stellenbosch University, whereafter she went to South Korea to teach English. She joined the University of the Free State (UFS) in 2014 as a facilitator at the Unit for Academic Language and Literacy Development (ALLD). In 2016, she completed an Honours in Psychology from Unisa. She was appointed as lecturer in the Dept. of Afrikaans & Dutch, German and French in 2018.

With her thesis, titled: 'N VOORGESTELDE ONDERRIGMODEL VIR DIE AANLEER VAN AFRIKAANS AS VREEMDE TAAL IN 'N AANLYNOMGEWING, the candidate has managed to develop an online teaching model for foreign language teaching in a low-tech environment with the focus on Afrikaans as foreign language. In order to develop a model for online foreign language teaching, the candidate has reviewed all aspects relevant to foreign language acquisition, including adult language learning, various teaching approaches and curricula design. The second part of the thesis focuses on the evaluation of an existing course, Gesellig Afrikaans, with regard to the ideal of the model. Where shortcomings were evident, the candidate made concrete recommendations for improvements based on the ideal teaching model and the quantitative feedback from former students. The external international examiner concluded, "This type of study is of critical importance in an educational context, especially as multiple sources of evidence (theoretical and empirical data from former students) have been collected."

THE HUMANITIES

Peter Taljaard matriculated in 1987 from Krugersdorp High School. He graduated from the University of Pretoria in 1993 with B.A. Drama and obtained his B.A. Hons in Drama and Theatre Arts in 2006 at the University of the Free State (UFS). He acted as a professional actor for PACOFS for six (6) years and was co-founder of the Free State Ensemble at the Observatory Theatre. The UFS awarded his M.A. in Drama and Theatre Arts in 2010, titled "The State of Professional Drama in the Free State Performing Arts Council."

With his thesis, titled: **GERBEN KAMPER'S LIFE, WORK AND CONTRIBUTION TO THE SOUTH AFRICAN THEATRE: 1972-2016**, the candidate makes a valuable contribution in the field of biographical and historical research in Theatre Arts. The candidate reconstructs Kamper's life and artistic history based on biographical narratives, documents and legislation regarding Arts policies (Roberts). The merit of his contribution is aiding the task of understanding the influences on Kamper's artistic contribution and personal vision for theatre arts during major shifts in the theatre industry from the Performing Arts Councils (1962 – 1996) and the impact of the 1996 White Paper on Arts, Culture and Heritage on his career as a professional actor, director, artistic director for the dubbing at the SABC, at Pacofs, the Observatory theatre and valuable influence on drama students as a senior lecturer at the Drama Department, UFS. The interrelationship between his choice of work, execution thereof, comment, and critique from various sources underpins the finding that Kamper contributed exceptional artistic merit to theatre in South Africa.

DOCTOR OF PHILOSOPHY WITH SPECIALISATION IN ENGLISH

NDAGO, Abenea Odhiambo

Abenea Ndago was born in Kisumu, Western Kenya, in 1979. He completed secondary school education at Onjiko High School in 1996. He obtained both a Bachelor of Education (Arts) Degree in Linguistics and Literature in 2002 and a Master of Arts (Literature) in 2010 at the University of Nairobi. He taught high school English from 2005 to 2008. He is currently a part-time Literature lecturer at Kenyatta University.

With his thesis, titled: **FICTIONAL REPRESENTATIONS OF ETHNICITY, NATIONHOOD, AND IDENTITY IN KENYA'S KWANI? JOURNAL AND OTHER KWANI TRUST PUBLICATIONS**, the candidate contributes to scholarship on the role that popular cultural productions play in the construction and imagination of nationhood in Kenya. The study, which draws from Anderson's theorisation on nation formation, and from concepts such as Bhabha's dissemination, Barber's subversion, and Fabian's view on the influence of socio-political context on popular texts, is a departure from the romantic view of Kenyan popular culture. It argues that Kwani? Journal's interpretation of ethnicised constructions of Kenya's nationhood and national identity colludes with, rather than contests, State metanarratives. Ndago's findings contradict conservative associations of Kenyan popular texts with youth subversion. Therefore, the study calls for an appreciation of the problematic role Kenyan and African popular culture plays in the imagination of nationhood in the larger continent.

DE WET, Wouter Jocobus

Wouter de Wet was born on 25 March 1989 in Ceres in the Western Cape. He matriculated at the Charlie Hofmeyr High School in 2007, after which he undertook his tertiary studies at the University of Stellenbosch. He graduated with a BA (Language & Culture) degree in 2010, BA Hons (History) cum laude in 2011, and an MA (History) in 2013. The following year he started his career as an English teacher in South Korea, and in 2 2015 he was appointed full-time lecturer in the History Department of the University of the Free State QwaQwa Campus.

With his thesis, titled: 'N GESKIEDENIS VAN DIE SUID-AFRIKAANSE RUGBYRAAD (SARR): ONTSTAAN, ONTWIKKELING EN VROEË BEDRYWIGHEDE, 1889-1956, the candidate provides an institutional and archival based history of the changing manner in which South African rugby has been administered over a period of 67 years. The way in which political currents impacted on the dynamics of the Rugby Board is Investigated in depth.

NYAMA, Vellim

Vellim Nyama was born on 23 August 1981 in Harare, Zimbabwe. He matriculated at Nyazura High school in 2001 and obtained a Bachelor of Science Honours Degree in Sociology in 2007 and Post graduate Diploma in Project Planning and Management in 2010 at the University of Zimbabwe. In 2013 he completed his Master of Science degree in Development Studies at the National University of Science and Technology, also in Zimbabwe. Prior to pursuing his doctoral studies at the University of the Free State, Vellim worked for a number of development organisations in Zimbabwe and Africa.

With his thesis, titled: AN ASSESSMENT OF CITIZEN PARTICIPATION IN LOCAL DEVELOPMENT: THE CASE OF MUREWA DISTRICT IN ZIMBABWE, the candidate contributes to scholarship on citizen participation as a critical factor in local development. Using a mixed methods approach, the researcher sought empirical evidence on the topic. Contrary to the expected outcomes of the decentralisation that was adopted in Zimbabwe, the study established that officials at local and central government levels still practice centralisation, limiting citizens' participation in decision-making. Citizen participation was mostly passive due to lack of empowerment, as well as lack of information on policy making. However, citizens are conscious of their role in local development and believe that they are the custodians of their communities.

DOCTOR OF PHILOSOPHY WITH SPECIALISATION IN LANGUAGE PRACTICE

TEDJOUONG TALLA, Jean Ebenezer

Ebénézer Tedjouong was born on 10 October 1972 in the Western Region of Cameroon. He graduated from the University of Yaounde with a B.A. in English and French (1995) and a Master's in Education (1997). His translation studies journey started when he completed a Master's in Translation as overall best postgraduate student in the University of Buea in 2002. After completing a PGD in Conference interpreting (2004), he has worked as a translator, interpreter, translation lecturer and interpreter trainer for over a decade. He presently lectures at the University of Buea and works as a consultant for leading international organisations.

With his thesis, titled: **CONCEPTUALIZING INTERPRETER EDUCATION IN A DEVELOPMENTAL CONTEXT: THE BUEA PROGRAM AS CASE STUDY**, the candidate makes a valuable contribution to the field of translation and interpreting studies. With this contribution, he situates and studies the interpreting programme of the University of Buea in Cameroon in terms of the development needs in Cameroon. The study found a significant gap between the programme and its context as well as an overemphasis on centralised and formal sectors in the economy, with the consequence that interpreting in public service contexts is neglected. It showed the entrenched conflicts of interest underlying the curriculum, the single level of certification to which the curriculum leads and the consequent lack of diversification in terms of languages and domains of application. The study calls for African universities to rethink their interpreter training in the light of the current development context.

CHAPANGA, Evans

Dr Evans Chapanga is a BA, BA Honours and MA graduate of the University of Zimbabwe. He is also currently a Lecturer in the Department of Linguistics of the same university. Dr Chapanga is an emerging scholar in the field of sociolinguistics and language for specific purposes with a focus on the growing research field of Critical Discourse Analysis of political texts in post-2000 Zimbabwe.

With his thesis, titled: A CRITICAL DISCOURSE ANALYSIS OF ZIMBABWE'S TRANSITIONAL STABILISATION PROGRAMME (TSP) WITH SPECIFIC REFERENCE TO POTENTIAL IMPLEMENTATION DYNAMICS, the candidate contributes to scholarship on Critical Discourse Analysis (CDA) through a thorough linguistic examination of Zimbabwe's Transitional Stabilisation Plan (TSP). The candidate clearly has a detailed and nuanced understanding of the socio-political context of Zimbabwe. The candidate was able to situate the socio-political contexts in which the TSP was produced. He is intimately familiar with the history and contemporary dynamics of Zimbabwe. Because of his familiarity with the socio-political contexts in Zimbabwe Evans Chapanga is able to capture the subtle meanings which an analyst who was not familiar with the history and contemporary dynamics of Zimbabwe missed. The thesis also displays the candidate's impressive familiarity with the Norman Fairclough brand of Critical Discourse Analysis (CDA).

The Main Procession graduation gowns – embroidered with rich diversity

outh Africa, and the Free State in particular, has a long-standing friendship with our neighbouring country, Lesotho.

Through a shared history, we have become co-creators of our futures. For this reason, the UFS decided to incorporate our tradition with that of the Basotho in the design of our Main Procession graduation gowns.

The gowns are inspired by the Seanamarena – the traditional Basotho blanket. The different patterns on the Seanamarena indicate the status one holds in the Basotho nation or reflect the occasion being celebrated. Keeping the Seanamarena pattern in mind, we combined our traditional academic designs with that of the Basotho nation.

YOKE PATTERNS






Yoke pattern for the Chancellor and Vice-Chancellor

This Seanamarena pattern is an interpretation of a design – used exclusively for the king and chiefs – which means 'to swear by the king'. This blanket has the highest status of all Basotho blankets.

Yoke pattern for the Chairperson of the Council

This Seanamarena Victorian crest motif appeared after the visit of the Prince of Wales to Lesotho in 1925, which made a profound impression on the local people. Customers refer to this blanket as 'lesiba' – meaning feathers – when buying it.



Yoke pattern for the Vice-Rector

This Seanamarena Poone design symbolises good crops, wealth, and fertility. The Poone is given as a present to honour an important visitor.



Yoke pattern for Registrar

The same Seanamarena Poone design used for the Vice-Rector applies to the Registrar, with some slight design and colour alterations.

The Deans wear gowns made in the colours of the faculties, or others which indicate the office they hold.
