ABOUT THE UFS

The University of the Free State (UFS) is one of the oldest institutions of higher education in South Africa. It opened its doors in 1904 in Bloemfontein as the Grey University College, with six students in the Humanities. Since then, the institution has grown to more than 40 000 students, spread over three campuses and across seven faculties (Economic and Management Sciences, Education, Health Sciences, the Humanities, Law, Natural and Agricultural Sciences, Theology and Religion).



DEVELOPMENT OF THE UFS CREST OVER MORE THAN A CENTURY

1904

Up to 1935, the same coat of arms was used as the Grey College School.



1935

By 1935, with the name change to University College of the Orange Free State, the coat of arms fell into disuse, especially among students.

1947

In 1947, an agreement between management and students led to the new motto Per Fidem ad Sapientiam (Through faith to wisdom).

1950

In 1952, it was changed to In Deo Sapientiae Lux (In God is the light of wisdom). The traditional orange, white and blue, linking the UFS to the South African national colours, changed in the late 1990s.

The orange was replaced by cherry red.

The academic brand - the historic University of the Free State crest that has been the symbol of the university since 1952, has evolved to embrace the aesthetic expectations of the stakeholders. The shape of the traditional academic shield has been simplified and contemporised. Much of the symbolism of the crest remains intact, acknowledging the location of the UFS brand as one of the country's premier institutions of higher education, with a proud history of academic excellence and an ever evolving, vibrant culture.

HONORARY DOCTORATE

JUSTICE ZAKERIA MOHAMMED (ZAK) YACOOB



Justice Zakeria Mohammed (Zak) Yacoob is a retired Justice of the Constitutional Court of South Africa. He became blind at the age of 16 months after contracting meningitis and matriculated at the Arthur Blaxall School for the Blind in Durban.

He completed his LLB at the University of Durban-Westville (UDW), where he joined the ANC underground movement. As an advocate (1973-1998), he defended political prisoners charged with defying the unjust apartheid laws, challenged detentions without trial, house arrests, and other restrictive decrees. Justice Yacoob also participated in anti-apartheid and community organisations, including the United Democratic Front, Detainees Parents' Support committee, DHAC, and disability organisations.

He was part of the Democratic Lawyers Association and took silk in 1991. Justice Yacoob participated in:

the negotiation process, and played a role in finalising the Bill of Rights in the 1993 Interim Constitution;

the Independent Electoral Commission responsible for South Africa's first democratic election in 1994;

the Independent Panel of Experts that advised the Constitutional Assembly in preparing the 1996 final Constitution.

As judge of the Constitutional Court of South Africa from 1998 to 2013, he became known nationally and internationally for his contribution to the socio-economic rights jurisprudence of South Africa.

Justice Yacoob attended national and international conferences and workshops on human and socio-economic rights, constitutionalism, disability, and blindness. He was also Chancellor of the UDW (2001- 2003). Justice Yacoob received the 2013 Felicia and Sydney Kentridge Award for Service to the Law in Southern Africa, and honorary doctorates from the Universities of Fort Hare, KwaZulu-Natal, Witwatersrand, Stellenbosch University, and the University of Pretoria.


He was Chair of SANAC Trust, served voluntarily on the boards of various civil society organisations, and as ombud at the University of KwaZulu-Natal.

Justice Yacoob participated in local and international commissions, among others, into a SARS commissioner's fitness to hold office and assessing the correctness of the conviction of the Cuban Five by the USA in London (March 2014). He chaired the People's 2015 Tribunal in the Netherlands into atrocities committed in 1965 by the then Government of Indonesia; and chaired a People's Tribunal into Economic Crimes in South Africa (2018).

Justice Yacoob retired as judge of the Constitutional Court at the end of January 2013.

With his thesis, titled: A LEADERSHIP COMPETENCE FRAMEWORK FOR THE BEVERAGES MANUFACTURING INDUSTRY IN ZIMBABWE, the candidate developed a leadership framework (LCF) for Sustainable Development (LCFSD). A synthesis of sustainable development and leadership theories resulted in a draft LCF that informed a qualitative field enquiry. A subsequent thematic data analysis, interpretation and validation produced a LCFSD metaphorically depicted by a bicycle. It comprises the following pillars: strategic competences; core competences; core values and collaborative competences. She obtained a degree in Banking and Finance in 2014 and a master's degree in Finance and Investment in 2016, both from the Institute of Finance Management in Tanzania. She then pursued her PhD in development studies (2018-2020) at the University of the Free State.

With her thesis, titled: HIGHER EDUCATION AND HUMAN DEVELOPMENT: STUDENTS' AND GRADUATES' PERSPECTIVES FROM TWO TANZANIAN UNIVERSITIES, the candidate contributes to the scholarship on the developmental role of universities in Africa. Using a mixed methods approach, she draws on the perspectives of students and graduates in two Tanzanian universities, one public and one private to explore broader role of universities. While the dominant realisation of the value of universities in Tanzania aims predominantly at economic competitiveness and opportunities, there are instances of concern about human development, especially from the participants' identification of valuable beings and doings, which involved both economic and social values. The study argues that universities are social institutions that ought to contribute to the public good to foster both economic and human development in broad ways, and that this is consistent with a decolonial vision. Universities should not be seen as commodities for profit generation, but as institutions that contribute to the needs of society.

Thesis Title: NARRATIVES OF CAPABILITY FORMATION FOR STUDENTS WITH LEARNING DISABILITIES AT A SOUTH AFRICAN UNIVERSITY

Ndakaitei Manase was born in 1977 and grew up in Bocha Mutare, Zimbabwe. She attended school at Murehwa primary and Marange high school. Her tertiary education journey began at Mutare Polytechnic College, Zimbabwe where she obtained a Higher Diploma (Secretarial Studies). She later enrolled for a Postgraduate Diploma (HIV/AIDS Management) at Stellenbosch University, South Africa and graduated with a distinction in 2011. She proceeded to a Master of Philosophy (HIV/AIDS Management - Stellenbosch). In 2017, she obtained another master's degree in Sociology (Cum Laude) at the University of the Free State and in 2018, started her study for the Doctor of Philosophy.

With her thesis, titled: NARRATIVES OF CAPABILITY FORMATION FOR STUDENTS WITH LEARNING DISABILITIES AT A SOUTH AFRICAN UNIVERSITY, Ndakaitei Manase contributes original knowledge to the growing field of learning disabilities in higher education. The candidate analysed the narratives of students with learning disabilities, and interviewed lecturers and staff members at the UFS Centre for Teaching and Learning and the Disability Unit, as well as interrogating relevant policy documents to produce a rich account of students' learning experiences. The study identified a set of human capabilities or freedoms that includes the capability to demonstrate one's full potential, which can be enhanced by disability support. The study established that, while there are university arrangements that enhance students' capabilities, students with learning disabilities are also stigmatized through separate provision of support. The study thus recommends the institutionalisation of university spaces and all educational components should be designed to accommodate diversity and enable students with disabilities to achieve the educational and general life goals they value.

Martino Kamwano Mazinga was born on 23rd of November 1977 in Dowa District, Malawi. He did his secondary education at Mlale Minor Seminary. He attained a Diploma in Philosophy (Distinction), Bachelor of Arts in Philosophy (Magna Cum Laude) at St. Joseph's Institute in South Africa, before he studied for Masters of Arts in Literature at University of Malawi and Masters of Development Studies at the University of the Free State. Martino's professional career in humanitarian and livelihood programs with rural communities in Malawi has seen him rise to the ranks of National Director for the Catholic Development Commission – Caritas Malawi.

With his thesis, titled: **THE ROLE OF PUBLIC UNIVERSITIES IN FOSTERING GRADUATES' CAPABILITIES FOR RURAL DEVELOPMENT IN MALAWI**, the candidate contributes to scholarly knowledge on the broader topic of higher education and rural development. The candidate re-affirms the ongoing calls for universities' contextual relevance in graduate preparation. He argues that universities can foster graduates' capabilities for rural development through rural sensitive curricula and pedagogies that would stimulate or expand their agency and aspirations for rural poverty reduction. The candidate re-imagines a different kind of university that is oriented towards promoting human development in contexts of rurality and rural poverty. He proposes a multi-layered framework of graduate preparation that is contextually oriented, capability-based, and recognizes multiple conversion factors that influence graduate training. The candidate argues that graduate preparation ought to go beyond a focus on employability attributes and foster capabilities, agency and aspirations for rural social change.

Schooled at Hoërskool Die Kruin and matriculating in 1989, Henine Jordaan has been a lecturer in Economics at the former Vista University and current Central University of Technology since 1995. She has a strong background in community service engagement in the Lejweleputswa District in collaboration with the Free State's Department of Basic Education. This passion to uplift disadvantaged communities has been a natural motivation for a PhD focusing on the access to finance of SMMEs in deeply rural South Africa. Henine is married and has three children, one of which who shares her love for Economics and completed his master's degree in 2020.

With her thesis, titled: **SMMES' ACCESS TO FINANCE FROM FORMAL LENDING INSTITUTIONS IN THE FREE STATE GOLDFIELDS**, she investigates the factors affecting the access to finance of SMMEs in the Matjhabeng municipal area through a mixed-methods research design. The results provide valuable insights into understanding not only the criteria banks use to assess the granting of loans to SMMEs in impoverished rural areas, but also the perspective of the SMMEs themselves regarding the challenges they face when dealing with banks. Although banks were found to be accommodating in their policies to grant credit, the nature and extent of their risk-aversion mindset evidenced in the lending process were found reduce the likelihood to award loans. Given that they have stringent regulatory and legislative requirements to adhere to, the study provides practical recommendations to both banks and the owners of SMMEs that can improve the likelihood of accessing credit for SMMEs in rural areas across South Africa.

Thesis Title: MONETARY AND FISCAL POLICY SPILLOVER AND COORDINATION IN THE SACU AREA

Duduzile Ndlovu was born on the 21st of November 1982 in Moscow. She matriculated at Matopo High in Zimbabwe in 2001 and attained a BSc Honours degree in Economics in 2005 at the University of Zimbabwe. She graduated with a BCom Honours in Applied Econometrics in 2008 and a Master of Commerce in Applied Econometrics in 2009 at the UFS. Her career began in 2009 as a lecturer at the Department of Economics at the UFS. In 2011, she was appointed as a researcher in the Faculty of Economic and Management Sciences, a position she holds to date. She is married to Mr Sindiso Ndlovu and has a son, Khanya.

With her thesis titled: **MONETARY AND FISCAL POLICY SPILLOVER AND COORDINATION IN THE SACU AREA**, the candidate contributes to the literature on economic and monetary integration, focusing on the Southern African Customs Union (SACU) region. By investigating the nature and degree of policy spillover effects and policy coordination across the SACU region, she explores the economic, monetary and fiscal policy case for the SACU region to become a fully-fledged monetary union. In her thesis she employed various econometric techniques to explore the degree of economic, monetary and fiscal integration and policy spillover. The study concludes that, while monetary policy spillovers and the spillover effects seen through testing the South African dominance hypothesis make a case for monetary integration and a monetary union, the lack of coordination between fiscal and monetary policy means that fiscal and monetary policy coordination first needs to improve before a move can be made towards full monetary integration.

With this contribution, he identifies the supply chain barriers that impede service delivery in local governments and presents a framework for how these barriers can be overcome. The exploratory qualitative research results of this investigation serve as an indication of the value this type of intervention holds for the attempt to find a solution to improved service delivery in local governments. The study concludes that barriers in the supply chain impede service delivery in local governments and that a framework for the management of the supply chain can overcome these barriers and therefore result in improved service delivery.

A team was established to design a strategy and set goals from different perspectives, teachers were encouraged to share learning and pool their resources together. Through the use of intra-organisational resources, awareness training on communication competency was applied. Team teaching was used.

While the teachers appear to have adequate mastery of the content related to force and momentum, there was a mismatch between their knowledge and its expression in practice during teaching. The mismatch is partly attributed to the teachers' lack of and/or insufficient planning of lessons and lesson events. The study recommends the need to develop a system and culture of thorough planning of lessons by groups of teachers and anticipation of possible student responses, akin to what the Japanese do during Lesson Study.

Mamontsuoe Lintle Maraisane was born on the 31st of January 1976 at Roma, Maseru, Lesotho. She obtained her Primary Teachers' Certificate in 1998 at the former National Teacher Training College currently called Lesotho College of Education whereby she works as a Head of Department in Early Childhood Development and Special Education. She was awarded a BEd (Pre-school and Foundation Phase) with distinction by the University of the Free State (UFS) in 2007. She attained an honours degree in Curriculum Studies in 2010 at the same university. The Faculty of Education awarded her the best performer in Master of Education Degree in Curriculum Studies in 2013.

With her thesis, titled: THE INFLUENCE OF GRADE R TEACHERS' SCIENCE CONTENT KNOWLEDGE ON THEIR CLASSROOM PRACTICES, the candidate contributes to scholarship in the early childhood education sector and science teaching by exploring how Grade-R teachers translate their science content knowledge into effective classroom practices. Using a mixed-methods approach, a survey of 100 Grade-R teachers' science content knowledge informed the selection of four teachers to be interviewed, observed and their lesson plans analysed for further insights on the relations between knowledge and classroom practice. The study found that teachers' science content knowledge was fragmented. While they had the expected common content knowledge, limited specialised content knowledge and adequate horizon content knowledge, their content knowledge generally had weak or no influence on classroom practices. The study recommends that teacher training institutions and Ministries of Education need to organise ECD programmes to enhance teachers' content knowledge to align with classroom practice.

Quality assurance in the current regulatory framework was analysed and contextualised to establish what is required and its impact on the operations of public and private providers. A mixed methods research approach was used to investigate the experience of public and private TVET with the current QA system in South Africa. The study concluded that there is a need for a centralised oversight body with a far more streamlined system, better stakeholder consultation, less political interference and with a deeper appreciation of the contributions both public and private TVET providers make to the education and training of learners in South Africa and of a standard commensurate with international standards.

With his thesis, titled: **THE MANIFESTATION OF FETHULLAH GÜLEN'S EDUCATIONAL PHILOSOPHY IN HORIZON EDUCATIONAL TRUST SCHOOLS IN SOUTH AFRICA**, the candidate subjectively (re)constructs an education philosophy constituting Islamic thought, openness, tolerance, and social activism. His cogent analysis of the extent to which Gülen's philosophy manifests in Horizon Educational Trust schools' policies and practices provides a rigorous interpretation of Islamic intellectualism. The study reveals that key themes constituting Gülen's philosophy can be traced in policy and practice, albeit in a haphazard manner. The candidate recommends that a well-articulated philosophy of education that foregrounds holistic education as a significant component would contribute towards a common understanding of Horizon Education Trust schools' aims and objectives. The candidate argues that a written policy on the interplay between guidance (*rehberlik*) and teaching by example (*temsil*) should be extended to include values embedded in African philosophy of education.

Dirk Thomas Hagemeister is a German born and trained family physician. After obtaining a research-based MD in 1999 and serving in various functions in the German Armed Forces Medical Services, he joined his South African wife in her home country in 2005. In addition to his professional qualifications, which include diplomas in emergency care, sports medicine and HIV management, he holds a BA in Philosophy and History and master's degrees in public health and in bioethics. He is involved with academic training since 2008, with a focus on emergency training as BLS, PALS and ACLS instructor.

With his thesis, titled: A FRAMEWORK FOR INTEGRATED EMERGENCY CARE EDUCATION IN SOUTH AFRICAN UNDERGRADUATE MEDICAL PROGRAMMES the candidate explores the regulatory environment, the international scholarly body of knowledge and the current practice of undergraduate medical training in emergency care. Employing qualitative research methodology, in-depth interviews with key informants at South African medical schools are complemented by nominal group technique research with graduates from one of the programmes. Themes and categories derived from these empirical parts are compiled into a framework. This framework tries to illustrate the complex relationship between the three constituents of high-standard clinical practice, up-to-date educational practice and institutional culture. While thematically rooted in the specific topic of emergency care training, through improved understanding of the factors influencing the teaching practice, such a framework might also contribute to the improved teaching of other inter-disciplinary, longitudinal themes in undergraduate medical education.

Riaan van Wyk was born on the 6th of April 1977 and matriculated at Jim Fouche High School (Bloemfontein) in 1995. He obtained a BComm (IT) degree at the University of the Free State in 2000 and joined the private sector as IT Systems engineer. His involvement in tertiary education began in 2012 as technical expert at the Clinical Simulation and Skills Unit at the University of the Free State. He obtained his Postgraduate diploma in Health Professions Education in 2014 and a Master's degree in Health Professions Education in 2016.

With his thesis, titled: **THE ROLE OF A SUSTAINABLE INTEGRATED SYSTEMS APPROACH TO HIGH-TECHNOLOGY CLINICAL SIMULATION IN SOUTH AFRICA**, the candidate contributes to scholarship in clinical simulation. Using a multimethod approach, data were collected from simulation facilities at South African public, accredited health professions training institutions. Data gathering covered six operational subsystems, namely management, funding, staffing, physical environment, curriculum integration and research. This information was used to identify challenges experienced by the facilities in hightechnology simulation activities in these operational subsystems. A Delphi questionnaire was developed to reach consensus amongst simulation experts on approaches to alleviate the various identified challenges. Using the results of the Delphi questionnaire, recommendations and guidelines were developed not only to address the challenges but also to illustrate how the different subsystems influence each other. Although the focus is on high-technology simulation, the majority of recommendations and guidelines will be applicable to all simulation activities.

Currently, she is a lecturer in the Department of Nutrition and Dietetics.

With her thesis, titled: DEVELOPMENT OF A NUTRITION SCREENING TOOL FOR THE PREDICTION OF BIRTH OUTCOMES OF WOMEN ATTENDING THE ANTENATAL CLINIC AT PELONOMI HOSPITAL, the candidate makes a meaningful contribution to understanding factors that are associated with poor birth outcomes, including premature birth, stunting and wasting at birth. A total of 682 pregnant women attending the antenatal clinic at Pelonomi Hospital were included at baseline and 331 mothers with their 347 babies were included in the follow-up phase of this study. Based on the variables identified as independent predictors of overall birth outcomes, the candidate developed an 8-item nutrition-related screening tool to detect those pregnant women who are at risk of poor birth outcomes. The screening tool can assist nursing staff to identify high risk pregnancies and to refer at an early stage, when nutrition intervention can still positively impact on birth outcomes.

With her thesis, titled: A RISK ASSESSMENT PROFILE AND DIET QUALITY INDEX FOR INADEQUATE CHOLINE INTAKE IN PREGNANT WOMEN IN BLOEMFONTEIN, SOUTH AFRICA, the candidate makes a meaningful contribution to understanding choline intake in pregnant women. Adequate choline intake and optimal diet quality play a critical role in normal development of the foetus and the short- and long-term health of the offspring. Dietary intake (including intake of the nutrient choline), anthropometry, medical history and household food security were determined in a sample of 682 pregnant women attending the antenatal clinic at Pelonomi Regional Hospital. Factors that could affect choline intake in this population were identified. In addition, a diet quality index, with a focus on choline-rich foods, was developed for use in pregnant women in South Africa.

The necessity for individual practicality of current and future recommendations and strategies demands recognition and the consequence of an individualised dietary approach prior to endurance events should only be implemented after trial and error practices. She encourages endurance athletes to apply dietary strategies within the framework of their training setting, body composition and physiological needs, and attend to their nutritional requirements to ensure good health, encourage optimal performance, and decrease the likelihood of burn-out and, consequently, injuries.

Results are provided on the prevalence of possible DCD in the Mangaung District's low socio-economic environments, leading to an increased awareness to ensure earlier intervention for children experiencing motor difficulties. Furthermore, the study determined whether teachers could identify children with DCD and highlighted the importance of identifying an appropriate screening tool for teachers to use for early identification. The candidate's literature review was used to develop an e-Delphi survey that provided insights from experts in the field of Kinderkinetics on important components to include in a motor intervention framework for children with DCD. A motor intervention framework was developed as the starting point to assist children with DCD, specifically in the field of Kinderkinetics. Two articles have been accepted for publication in accredited journals.

The potential role of astrotourism activities in the diversification of experiential offerings within South African National Parks is explored. The investigation contributes to knowledge relating to astrotourism and its potential to be developed in a responsible manner as a low environmental impact activity within South African National Parks. The candidate has achieved a local and global reach with the study culminating in the development of the Four-Component Operational Astrotourism Model. This approach provides comprehensive practical input to implement astrotourism activities.

The study identified increasing levels of pre-treatment drug resistance in newly diagnosed HIV-infected infants, however, protease inhibitor resistance remained rare. The findings confirmed the continued efficacy of recommended antiretroviral regimens for initiating treatment and the utility of dried blood spot samples for surveillance activities. The prevalence of HIV drug resistance in children and adolescents failing antiretroviral treatment was also shown to be increasing, impacting negatively on current and future treatment options for these patients. These findings highlight the importance of access to HIV drug resistance testing both at an individual and programmatic level.

She started her career as a music educator in Pretoria in 1980. In 2009 she was appointed in the Department of Education, and at present, she is a music educator at the High School Burgersdorp.

With her thesis, titled: THE UNIFYING EFFECT OF MUSIC IN A COMMUNITY – A CASE STUDY OF THE LADY GREY PASSION PLAY, the candidate focuses on the extent to which music, as an integrated part of a community project, can be instrumental in building bridges in a diverse community. With this research into the unifying effect of music, she augments current scholarship regarding the degree to which positive social transformation may be effected through the hosting of an annual community project – in this case, the Lady Grey Passion Play. Using a qualitative method approach, conducting semi-structured interviews and observation as data collection methods, the study corroborates and reinforces the argument that selectively including music in community projects can contribute to inculcating positive change regarding mutual respect, reciprocity, group forming, cohesiveness and positive energy, thereby lessening potential conflict in a heterogeneous community.

Douglas Scott's research focuses on the intersection of the emotional, conceptual, practical and creative aspects of music. Because of the diverse nature of the integrations he seeks between disciplines, he draws from a wide range of influences,



including mathematics, semiotics and gesture theory. His investigations are heavily influenced by his practical experience as a performer and teacher of the flute, voice, piano and ukelele, as well as his forays into stage acting and directing. He is also an active composer whose works have been performed on four continents and was until recently the chairman of the arts advocacy organisation NewMusicSA.

With his thesis, titled: A RADICAL CONSTRUCTIVIST APPLICATION OF ZIPF'S LAW TO MUSIC AS A SEMIOTIC THEORY OF COGNITION, the candidate contributes to cognitive music theory exploring the use of a statistical device that can allow insights from music analysis to inform our understanding of the mind. Building on the work of Charles Sanders Peirce, he proposes a semiotic theory (the semiotic eigencycle) that connects the human capacity for signification with the notion of a harmony of ideas that flows continuously between states of concord and discord. The significance of such a tool is that it allows acts of music making to serve as constructive models of cognition. This affords the analyst a means to study the relationship between structures inherent in musical surfaces and their effect on structures produced by behaviour and perception with a tool that represents a precisely defined and falsifiable cognitive-theoretical account of the mind.

Jesse Scheumann was born in Illinois, USA on 1 October 1989. He received his secondary education in Minnesota, USA, where he matriculated from a home school programme. He obtained the BA in Biblical and Theological Studies with distinction in 2010 from University of Northwestern-St. Paul, the MDiv with distinction in 2014 and the ThM with distinction in 2015 from Bethlehem College and Seminary, and the MA in Linguistics with distinction in 2017 from the University of Minnesota. He currently lectures Hebrew as an assistant professor at Sattler College in Boston, Massachusetts.

With his thesis, titled: A SYNTACTIC ANALYSIS OF PHRASAL COORDINATION IN BIBLICAL HEBREW, the candidate contributes to the linguistic study of Biblical Hebrew by comprehensively analysing 2,714 occurrences of the conjunction "and" in the Pentateuch. While previous studies have proposed multiple meanings and special uses of the conjunction, this study shows how a single use as a coordinating conjunction can explain the full distribution of data. The candidate demonstrates that coordination always creates a semantically richer constituent, that patterns of repetition (or non-repetition) of the conjunction

indicate whether items in a list form sub-groups, and that word order signals whether or not ellipsis has occurred. Coordination thus has important implications for biblical interpretation. This study illustrates the importance of integrating several modes of analysis within complexity thinking for a comprehensive understanding of coordination when studying Biblical Hebrew. Major insights of the research were presented at an international conference in December 2020.

She obtained the degree Bachelor of Science in 2011, Honours Degree (Genetics) in 2012, Master's Degree (Genetics) in 2015 and a PhD (Animal Breeding and Genetics) in 2021 at the University of the Free State. Part of the research for her PhD was conducted in the United States of America at Iowa State University under the supervision of Professor Emeritus, Max. F Rothschild.

With her thesis, titled: **DETECTION OF SELECTION SIGNATURES AND GENES ASSOCIATED WITH FITNESS IN SOUTH AFRICAN AFRIKANER AND BRAHMAN CATTLE**, the candidate makes a valuable contribution to the South African livestock industry. The research first focused on methods that might be used to increase the density of genotypic data cost effectively by ways of genotype imputing and salvaging unusable genotypes. This high-density single nucleotide polymorphism (SNP) data was then used to detect the underlying genetic factors that may be associated with adaptation and fitness in the South African Afrikaner and Brahman cattle breeds as well as the biological pathways that may be associated with adaptation to the harsh environmental conditions. Results indicated that while selection pressure in the Brahman was focused on production, fertility and adaptation the focus in the Afrikaner was on fertility and adaptation. This is an indication that the Afrikaner is kept under a harsher production environment.

the Nelson Mandela University in Port Elizabeth in 2015 whilst continuing her PhD in Chemistry at the University of the Free State on a part-time base.

With her thesis, titled: A SOLID STATE AND KINETIC STUDY OF BIDENTATE OXYGEN DONOR COMPLEXES OF COPPER, the candidate contributes to the field of coordination chemistry and the solid-state structural behaviour of copper complexes, experimentally and theoretically. The study includes a detailed single crystal X-ray crystallographic investigation on a range of copper complexes, as well as a preliminary kinetic evaluation which enables basic principles to be evaluated that are associated with the oxidation of catechol. The guest for compounds showing anti-bacterial, anti-viral, anti-fungal as well as anti-parasitic properties has been a focus of pharmaceutical and chemical research for centuries. In continuation of the quest for more effective agents in this field of research, the present study focused on the synthesis and characterization of selected homoleptic and heteroleptic coordination compounds of copper(I) and copper(II).

[The examiner] couldn't help wondering how many people would have been willing to undertake such a study. The end result, however, is a remarkable compilation of data and an almost monumental thesis. The candidate has demonstrated a capacity to work independently and has presented a large body of original work. The candidate studied Geology at the University of Huelva, Spain. She has a master's degree in Geology and Environmental Management of Mineral Resources also conferred by the University of Huelva. She developed a novel water treatment system patented internationally and successfully used in South Africa and Europe. Co-authored one book, one book-chapter, six articles in high impact journals and 14 abstracts and proceedings. She offered eight talks in international conferences and was the keynote of a webinar hosted by the Association of Spanish Researchers in South Africa, the Spanish Embassy and the Delegation of European Union in South Africa.

Her thesis, titled: HYDROGEOCHEMICAL ASSESSMENT, WATER TREATMENT AND REVALORIZATION OF DUMPS, TAILINGS AND DRAINAGES PRODUCED AT PHALABORWA INDUSTRIAL COMPLEX, the candidates provides a comprehensive evaluation of Phalaborwa Industrial Complex, which led to the revalorization of the mining wastes as potential rare earth elements (REE) resources and as neutralization reagent, and culminated with the design of a water treatment system that would benefit from both characteristics of the wastes. The alkaline copper tailing was used to neutralize the extremely acidic wastewater from the phosphoric acid plant. The system, developed at bench scale, was able to remediate the water and, at the same time, to concentrate the REE contained in both the water and the tailing. This thesis attempts to find a solution to an environmental problem with the development of an eco-friendly and sustainable system that concentrate REE in a circular economy approach, while improving the quality of industrial wastewater.

Adriaan Odendaal was born on the 10th of August 1985 in Ermelo. After matriculating at Hoërskool Harrismith in 2004, he enrolled for a B.Sc. degree in Geology at the University of the Free State (UFS), completing his B.Sc. Honours degree at the UFS in 2010. In 2011 he registered as a part time M.Sc. student at the Department of Geology at the UFS, which was subsequently upgraded to a Ph.D. degree. From 2011 onwards, the candidate was appointed as a lecturer in the Department of Geology at the UFS.



With his thesis, titled: SEDIMENTARY CYCLES IN THE ADELAIDE SUBGROUP, SOUTHERN KAROO – A NEW PERSPECTIVE, the candidate makes a major contribution to understanding the early development of the Beaufort Group in the southern Karoo. The candidate conducted a sedimentological and stratigraphic investigation of the rocks of the Adelaide Subgroup of the Beaufort Group along the Nuweveld Escarpment. This entailed measuring seven lithostratigraphic profiles and tracing identifiable sandstone packages laterally, which aided in the identification and mapping of three lithostratigraphic units. These lithostratigraphic units represent three coarsening-upwards megacycles that are 100s of meters thick. The development of these coarsening-upwards megacycles is explained by the candidate as being associated with the advancement of tectonically influenced progradational distributive fluvial systems that deposited sediment basinwards. The candidate also documented, for the first time, the presence of lungfish aestivation burrows within the Lower Beaufort Group.

Evodia Kgotle was born on the 15th of July 1992 in Parys, South Africa. She matriculated at Boitlamo Secondary School in 2009. She graduated with a BSc degree at the University of the Free State in 2013. She later obtained a BSc (hons) degree in 2014 and MSc degree in 2016 from the same University. In 2014, she appointed as a practical demonstrated for undergraduate microbiology student Department of Microbial, Biochemical and Food Biotechnology at the University of the Free State. She served in this role until 2020.

With her thesis, titled: ELUCIDATING THE BIOLOGICAL ROLE OF 3-HYDROXY FATTY ACIDS (3-OH C10:0) IN THE PATHOGENESIS OF PSEUDOMONAS AERUGINOSA, the candidate contributes work that shows that 3-OH C10:0 may be a virulence factor that is relevant for studying the immune response to pseudomonal infections. Through using a number of in vitro models i.e. a murine macrophage cell line and laboratory animals (nematodes and rats), she was able to document the effects of 3-OH C10:0. The obtained findings provide insight into how 3-OH C10:0 may also stimulate the host immune response. It should now be possible to design gene deletion studies that impair the effects of 3-OH C10:0. Such studies could assist in highlighting the biosynthetic pathway for 3-OH C10:0 as a possible target for developing anti-virulence drugs.

In 2017 he joined CSIR as a PhD candidate, and he was also a part-time lecturer at TUT where he lectured general Physics modules (GPS115B, PHU161B, PHI105D, and ESL111T) for first-year students at Arcadia and Pretoria campuses from 2019 to 2020.

With his thesis, titled: **DEVELOPMENT OF LOW OPERATING TEMPERATURE GAS SENSING FOR ENHANCED DETECTION OF H₂S AND VOCs USING UNDOPED AND RARE EARTHS DOPED NIO BASED GAS SENSORS** the candidate made a substantial impact by correlating the gas sensing with the luminescence properties of p-type NiO semiconductor metal oxide (SMO) doped with various rare earths. This particular approach of linking the sensing and luminescence features of SMO is currently limited in the sensing community. This unique study has produced four high quality publications including one review article, while another three are currently under review. The student has also produced two book chapters for Elsevier. The international examiner found this thesis to be of the highest quality and recommended that the thesis be accepted unconditionally.

The candidate demonstrated the need for a functional Ciyawo Bible translation that responds to the complexity of the context appropriately. The narrative frames of history, Islam, and orality as they impact the Mozambican Yawo situation were presented, and a design for a new translation for Ciyawo speakers in Mozambique in reference to those frames was presented. This research contributes new information to the understanding of Ciyawo Bible translation, as well as insights regarding the various contextual frames of the Yawo situation as applied to Bible translation. The candidate also contributes to Bible Translation generally through the provision of a model by which other translation project stakeholders can benefit as they plan their own projects.

With this contribution, he attempts to address the struggle South Africans are facing in order to overcome its past of discrimination and prejudice on the basis of race, class, gender and age. The study applies intergroup contact theory to explore how intergroup contact may reduce social exclusion, discrimination and polarization among diverse groups. A qualitative methodology was used, and focus-group interviews were conducted to obtain data from participants in five multicultural AFM congregations. The concept of intersectionality is shown to be a suitable lens for understanding the intersection between race, gender, class and age. The religious and spiritual capital in multicultural congregations can become a space for healing and transformation.

Thesis Title: CONTEMPORARY CHRISTIAN FOLLOWERSHIP: THE EMMAUS NARRATIVE AS INTERPRETATIVE FRAMEWORK.

Pierre Burger Engelbrecht was born in Johannesburg on the 25th of July 1984. He matriculated at Hoërskool Jeugland, Kempton Park in 2002. He graduated with a Baccalaureus Theologiae (BTh) degree at the University of Pretoria in 2007 and a Master of Divinity (MDiv) in 2009 at the same University. He is married to Tarien and is the digital content manager at Ekerk. Ekerk is an online community of faith.

With his thesis, titled: **CONTEMPORARY CHRISTIAN FOLLOWERSHIP: THE EMMAUS NARRATIVE AS INTERPRETATIVE FRAMEWORK**, the candidate sheds new light on the concept of discipleship and helps facilitate a fresh conversation on discipleship. His research helps bridge the perceived gap between New Testament Theology and Practical Theology as well as between theology and praxis, using a hermeneutical explication and application of Luke 24:13-35 to give an interpretative framework for contemporary communities of faith. This is done by an in-depth narratological and theological explanation of the Emmaus narrative. The results show that Luke 24:13-35 provides new insights into largely ignored dimensions of discipleship and infuses the present theological discussion on discipleship with a broader missional understanding. It is pointed out that followership is a better epistemological framework for a contemporary understanding of discipleship and that the Emmaus narrative provides new insights into followership practices.

The Main Procession graduation gowns embroidered with rich diversity



outh Africa, and the Free State in particular, has a long-standing friendship with our neighbouring country, Lesotho.

Through a shared history, we have become co-creators of our futures. For this reason, the UFS decided to incorporate our tradition with that of the Basotho in the design of our Main Procession graduation gowns.

The gowns are inspired by the Seanamarena – the traditional Basotho blanket. The different patterns on the Seanamarena indicate the status one holds in the Basotho nation or reflect the occasion being celebrated. Keeping the Seanamarena pattern in mind, we combined our traditional academic designs with that of the Basotho nation.

THE TRADITIONAL BASOTHO BLANKET

YOKE PATTERNS





Yoke pattern for the Chancellor and Vice-Chancellor

This Seanamarena pattern is an interpretation of a design – used exclusively for the king and chiefs –which means "to swear by the king". This blanket has the highest status of all Basotho blankets.

Yoke pattern for the Chairperson of the Council

This Seanamarena Victorian crest motif appeared after the visit of the Prince of Wales to Lesotho in 1925, which made a profound impression on the local people. Customers refer to this blanket as 'lesiba' – meaning feathers – when buying it.





Yoke pattern for the Vice-Rector

This Seanamarena Poone design symbolises good crops, wealth, and fertility. The Poone is given as a present to honour an important visitor.

Yoke pattern for Registrar

The same Seanamarena Poone design used for the Vice-Rector applies to the Registrar, with some slight design and colour alterations.

The Deans wear gowns made in the colours of the faculties or others which indicate the office they hold.


