## **SAAPS Conference held in Stellenbosch**

The bi-annual conference of The South African Association of Political Studies (SAAPS) was hosted by the University of Stellenbosch this year. The theme of the conference was **Democracy in the First Decade of the 21**<sup>st</sup> **Century.** Dr Tania Coetzee (Programme Director: Governance and Political Transformation) presented a paper with the theme: Co-operative Governance and Intergovernmental Relations – Reality or Myth?

#### ABSTRACT OF PAPER

The effective functioning and correct implementation of co-operative governance and intergovernmental relations can be viewed as a myth. When public protests and instability are analysed, the main issue found at the heart of the problem is co-operation, implementation and co-ordination between the various spheres of government. Co-operation is needed to ensure satisfactory service delivery. The question can be asked if there is a direct relationship between the poor service delivery, public protests and co-operative governance and good governance.
