
# We don't stop going to school when we graduate. - Carol Burnett -

### The fourth Ph.D. Graduate of the Program Governance and Political Transformation

Dr. Pringle Cloete (pictured on the right with Dr Tania Coetzee)

**Title:** A critical analysis of the relationship between political transformation and corruption. As citizens of South Africa corruption has become endemic and an important relationship between political transformation and corruption has been established. A clear trend indicates how corruption manifests and progressively grows in almost every state undergoing a process of political transformation, with reference to the negative repercussions for the poor in particular. Case studies in three African states (Nigeria, Botswana and Zimbabwe) have been done prior to shifting the focus to South Africa, where both public sector departments as well as private sector experiences come under scrutiny established the necessary patterns. Apart from the broader South African environment, selected departments of the Eastern Provincial Government were also placed under the microscope as a continuation of the case-study approach. In an attempt to find solutions for the manifestation and increase of corruption during political transformation processes, the findings and recommendations



can be put forward. The establishment of a single independent law enforcement agency; the importance of strong political will and leadership to combat corruption; institutional controls and accountability to promote

# **RESEARCH SEMINAR**

It was again a great pleasure and privilege to listen to experts giving advice to Masters Degree Students during the Research Seminar held on 25-26 July 2013. The purpose was to provide advice and knowledge on research methodology including *The Meta-theory of social research; The importance of technical care in the writing of a dissertation; The essence of ethnographic research; Information gathering methodologies; and the Approach and challenges of part-time studies.* 

During the second day students interacted with facilitators, namely Dr Piet Croucamp, Dr Lenie Swanepoel and Dr Kallie de Beer. Students had to present and discuss their research in small groups and could find answers to the questions they posed to the facilitators and fellow students.

## Students are making a difference in governance practices

The **service learning** module within the B.A. curriculum provides a golden opportunity for students to gain firsthand experience on a **very practical level regarding governance issues within communities.** Students contributed to improved good governance practices at municipal level and especially at ward level. Students must analyze, assess and learn how ward councillors implement good governance principles.

They also obtained a better understanding of the theoretical framework of Political Science and Public Administration and Management and could clearly use and link the theory of the different subjects to understand the practical issues and problems experienced by communities and councils regarding good governance. They were able to identify the basic principles of good governance and could advice the community and councillors to implement good practices and improved service delivery. Different community's needs, problems and disputes were identified and discussed during **workshops and meetings** organised by the students themselves.

These matters were brought to the attention of the services sector (public servants in local government spheres). In the process the accountability of public servants, particularly ward councillors, was ensured. The community obtained a better understanding of the theoretical framework of political management and the difficulties with implementing decisions and policies. Community members voiced their opinions and shared their dreams, concerns and needs in an open and transparent manner.

Students also had the opportunity to **present their research findings, experience and very important, their understanding of governance and political transformation** during a formal presentation to colleagues, students and the ward councillors of the different wards.
