### The Value of a qualification in Governance and Political Transformation

Governance is a specialist area in academia. The core ideas and concepts regarding Governance explain the manner of governing and the actions and interactions of government. It explains how government makes decisions, how the government acts in the interest of the people and the citizens and how the government in collaboration with other stakeholders (network and partnerships), governs the country. The focus falls on good governance practices for example, accountability, responsibility, transparency and public participation. As citizens of South Africa we are aware of the difficulties and the challenges facing this country. Issues such as corruption, mal-administration and poor governance (lack of accountability, responsibility and transparency) are hampering the successful and prosperous country we can be. The BA, Post Graduate Diploma, Masters and Ph.D. Programmes in Governance and Political Transformation have a specific niche and focus, namely governance and political transformation. With scientific knowledge, analytical skills, strategic management and general background of governance and political transformation students are prepared to work in a public and private sector.

The purpose of the **BA degree in Governance and Political Transformation** is to equip the learner with a broad knowledge base of theory and methodology within the disciplines of Political Science, Public Administration and Management and Communication Science. The student will be able to apply the theory, principles and skills in a career context in order to enhance good governance practices in the private and public spheres. The advancement of political expertise (political literacy and academic skills) and the development of political management orientated skills (such as political environment analysis, political risk assessment, scenario development, policy analysis, political conflict analysis and management) in an environment of rapid change in order to comply with the needs in terms of institutional capacity building, leadership development, policy development, and the promotion of a value system which complements good governance and forms the basis of a democratic government.

The Postgraduate Diploma in Governance and Political Transformation is multi- and interdisciplinary in nature. It strengthens and deepens the student's knowledge in Governance and Political Transformation. The qualification allows for working professionals to undertake advanced reflection and development by means of a systematic survey of current thinking, practice and research methods in the area of governance and political transformation. Especially for adult learners it provides an opportunity to gain attributes which include academic and professional competence, effective knowledgeable workers by doing scientific research and becoming leaders in communities. The purpose of the programme is to promote good governance practices in areas of law and governance, corporate governance, ethics and governance, conflict management, municipal governance and to establish a value system for good governance in South Africa. Such attributes are needed and applicable at all three spheres of government, namely national, provincial and local.

The **Masters Degree Students** are given the opportunity to investigate original problems and issues through scientific research methodology and fill the lack in knowledge to improve good governance practices in government institutions and other social institutions. Contributions to the epistemology are necessary to bring about new knowledge in the domain of governance and political transformation.

#### **BA Governance and Political Transformation**

Postgraduate Diploma in Governance and Political Transformation Duration is one year, by completing eight (8) modules in areas that include, amongst others: Political Transformation and Management; Political Environment; Conflict Management; Cooperative Governance; Communication Management and Municipal Governance.

<u>Admission requirements</u>: B Degree or four-year National Diploma (NQF level 7). Average mark of 60% or higher will be considered. Closing date for applications: 3 November 2015.

#### Masters Degree in Governance and Political Transformation

Duration is one year, which includes examination on Research Methodology and the writing of an Extended Mini-dissertation.

<u>Admission requirements</u>: Postgraduate Diploma in Governance and Political Transformation or Honours qualification (NQF level 8). Average mark of 60% or higher will be considered. Closing date for applications: 3 November 2015.
