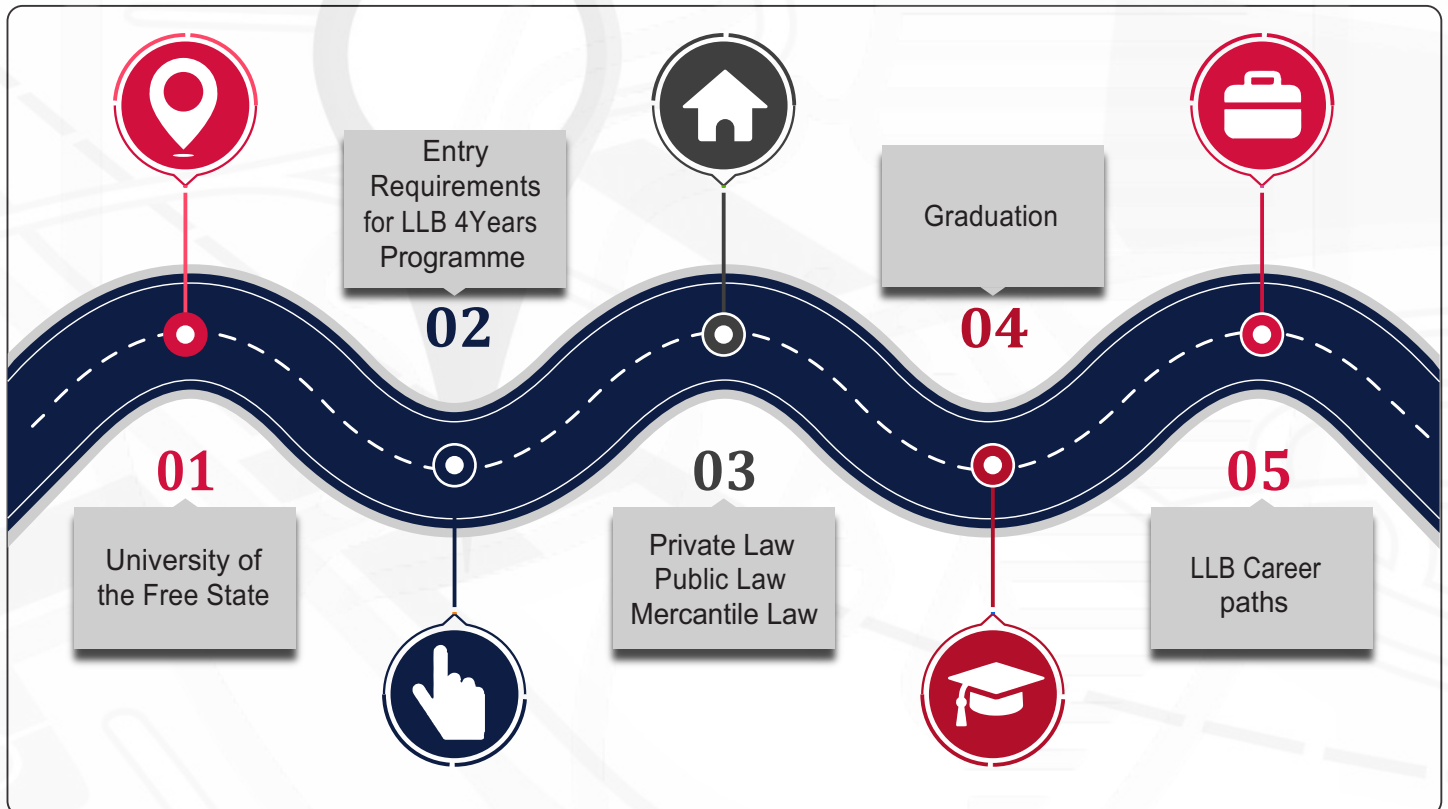




# Road Map to an LLB Degree at the Faculty of Law, University of The Free State

## Department of Private Law

The UFS Law Faculty, Private Law department is home to an academic staff that is diverse in their representation of South African society. Its academic staff boasts dynamic specialised research areas and legal practice expertise, providing students with the latest knowledge, legal developments, and socially responsive perspectives in private law.

The UFS Law Faculty, Private Law department offers its students all the fundamental undergraduate private law modules, such as Property Law, Family Law and Law of Persons, Contract Law, Law of Delict, Law of Succession and Legal Pluralism, and offers final year electives in specific private law disciplines for example Private International Law.

At postgraduate level, the UFS Law Faculty, Private Law department offers students in the LLM structured coursework programme the opportunity to specialise in any of the Private Law disciplines. Postgraduate students are able to select coursework modules that complement their research dissertation.

The UFS Law Faculty, Private Law department has proven itself to be one of the most innovative departments in its approach to student-centred teaching and assessment. The Private Law department prides itself on its use of cutting-edge technology to facilitate efficacy in its communication and service delivery to its students. ## The Department of Public Law

The Department of Public Law teaches an array of themes at undergraduate and postgraduate level, including foundational modules such as Constitutional Law, Human Rights Law, Criminal Law and Public International Law.

The Department also teaches modules inextricably connected to the law in general, including, Jurisprudence & Ethics, Interpretation of Statutes as well as Alternative Dispute Resolution.

The Department is nationally recognized for its scholarly specialization in Education Law, Freedoms related to Religious Beliefs and Cultural Practices as well as Environmental Law and is in the process of establishing a regional hub related to Africa's Reparations Agenda.

Then there are more practically orientated modules presented by the Department such as Law of Evidence, Law of Criminal Procedure, Practical Legal Skills, Clinical Legal Education and Law of Civil Procedure.

## The Department of Mercantile Law

The Department of Mercantile Law, in the Law Faculty, at the University of the Free State provides a distinctive opportunity to study basic principles and rules which governs, among others, the registration, organisation, and management of companies and other business forms, credit provisions, free markets, intellectual property, Labour Law, and instruments of payments as they apply to commerce and everyday life.
