## Faculty of Law Student appeal form

The Readmission and Appeals Committee of the Faculty of Law will only consider appeals from the following students:

- (a) Students who exceeded their residential periods in terms of the Faculty Rules and/or General Rules for Undergraduate Qualifications, Postgraduate Diplomas, Bachelor Honours Degrees, Master's Degrees, Doctoral Degrees, Higher Doctorates, Honorary Degrees and the Convocation (hereafter referred to as the General Rules);
- (b) Students who are academically excluded on the basis of non-compliance with Faculty Rules and/or General Rules dealing with progression provisions.
- (c) Students who need to repeat a module but permission cannot be granted in terms of General Rule A3.11 (Readmission on the basis of academic progress, subsequent to complying with paragraph A3.10).

Please refer to rule E9 of the Faculty of Law Undergraduate Rules that deals specifically with the Faculty's Readmission and Appeals Committee.

## **General instructions:**

- 1 Please ensure that you include all the required information in this form and that you disclose all relevant information here as you have **only one chance to appeal.**
- 2. Kindly provide **documentary proof of the statements contained** in your appeal and attach such to this form. It is acknowledged that such information may be of a **personal and very sensitive nature**. It is nevertheless required that you fully take the Faculty Readmission Appeals Committee into your confidence. **Any information of a sensitive nature will be treated in the strictest confidence** by the Faculty Readmission Appeals Committee. During this process, the UFS will comply with the terms of the PoPI Act (Protection of Personal Information Act 4 of 2013).
- 3. Kindly ensure that all the documents referred to or required are attached to this form. Incomplete appeal forms or appeal forms without substantiating documentation will not be considered.
- 4. Please note that **no additional supporting documents** will be accepted **after submission** of this appeal form.
