

Ensure that your application form is completed correctly and signed before returning it to the UFS. You should expect to receive feedback from the university within three weeks of sending your application.

The application process must be completed before arrival for registration at the university. Your details must be captured on the UFS database to facilitate the registration process. For this reason, adherence to closing dates is extremely important. Students transferring from other universities, must include a certificate of conduct, as well as a study record from their previous university with their applications. The closing date for students transferring from other universities is 30 September 2018. International postgraduate students must attach certified copies of degrees/certificates to their applications. Degrees/certificates that are not certified will delay the processing of applications.

If your application is successful, you will receive a letter of conditional admission from the admissions office, as well as a letter from the Office for International Affairs for the study permit. Visit the South African Embassy in your home country with the above letters, as well as your passport, to apply for your permit. Please be advised that your study permit application can take up to six weeks to be finalised.

The UFS confirms that all personal information provided in your application form will be treated confidentially and will not be sold to a third party or used for commercial or related purposes.

## **EVALUATION OF FOREIGN QUALIFICATIONS**

Postgraduate applicants must have all previous post-school qualifications verified by the South African Qualifications Authority (SAQA). Postgraduate students will not be able to register without the SAQA verification.

## INTERNATIONAL APPLICATIONS

All international students are advised to take note of the following:

- **Administrative fee:** A non-refundable administrative fee is charged on all international student accounts. For more information, visit https://www.ufs.ac.za/kovsielife/unlisted-pages/tuition-fees/tuition-fees-30
- **Closing date:** The closing date for international applications, is 31 August 2018.
- **Visa:** You must have a valid study visa before you can enter South Africa. Make sure your study visa is issued to study at the UFS and not at any other institution in South Africa. You must have a valid and appropriate/correct visa to be registered at the UFS.
- Medical Aid: You must be a member of a medical aid registered in terms of the Medical Aid Schemes Act 1998 of South Africa as
  required by the South African Immigration Act. Please note your medical aid cover MUST be valid for the duration of your studies at
  UFS. No travel insurance or hospital plans will be accepted.
- **Prepayment:** A prepayment must be made before you can register as a UFS student. The Department of Student Finance will communicate the amount and payment deadline to you. For further details, visit https://www.ufs.ac.za/kovsielife/unlisted-pages/tuition-fees/tuition-fees-30
- **Scholarships/Bursaries/Sponsorships:** If you have a scholarship, inform your sponsor of the UFS regulations on payments before you register and pay tuition fees.
- Applicants who are in possession of a degree from non-South African universities, must include the South African Qualifications
  Authority (SAQA) evaluation letter with their application form. Non-South African certificates/degrees must be assessed by SAQA
  prior to applying to the UFS. This process can take anything from two to three months. Visit www.saqa.org.za for more information.

B: researchers that enjoy considerable international recognition by their peers





# **Professor Melanie Walker**

Prof Walker leads the Centre for Research on Higher Education and Development (CRHED). She holds a prestigious National Research Foundation (NRF) Chair in Higher Education and Human Development and is an A-rated NRF researcher. The research programme is an opportunity to understand the impact of higher education in contributing to reducing inequalities from an interdisciplinary, comparative, multi-project perspective. Informed by the lens of human development and capabilities as conceptualised by Amartya Sen and Martha Nussbaum, universities, development and social justice are evaluated based on the extent to which 'capabilities' are created both for diverse individuals and building a society that values creating capabilities for the well-being and agency of all. Our current research projects investigate gender and higher education, higher education pedagogy, professional capabilities, student governance, employability and inclusive development. Since 2014, the programme has 12 PhD students and four master's (by research) students, as well as six post-doctoral fellows, a senior researcher and researcher.

# **Professor Hendrik C Swart**

## Focus area: Nanotechnology

Nanotechnology will provide tools for high-tech development as well as development in rural areas. The fabrication of phosphors will provide affordable lighting for those people, assisting with national infrastructure development, but it may also be used in high-technology plasma and field emission television screens. Prof Hendrik C Swart is a senior professor in Physics and holds a SARChI Chair. Over the past 20 years he has led research in the area of the degradation of phosphors for field emission displays, as well as developing materials for nano solid-state lighting. He has been key in the development of processes to synthesise and deposit thin films of various types of semiconductor nanoparticles which will enhance the colour, luminescent intensity and lifetime of such displays.

#### **Focus Area: Applied Mathematics**

Prof Abdon Atangana is a leading applied Mathematics professor at the UFS at the Institute of Groundwater Studies. He obtained his honours and master's degrees from the Department of Applied Mathematics at the UFS with distinction. He obtained his PhD degree in applied mathematics from the Institute for Groundwater Studies. He serves as an editor for 18 international journals and is also a reviewer of more than 200 international accredited journals and has been awarded the world champion of peer review twice, in 2016 and 2017. He also serves on more than 20 editorial boards of applied mathematics and mathematics. He has presented and participated in more than 20 international conferences and has been invited as plenary speaker in more than 10 international conferences of applied mathematics. His research interests are methods and applications of partial and ordinary differential equations, fractional differential equations, perturbation methods, asymptotic methods, iterative methods, and groundwater modelling.

Prof Atangana is the founder of the fractional calculus with non-local and non-singular kernels popular in applied mathematics today. Since 2013 he has published in 165 international accredited journals of applied mathematics, applied physics, geo-hydrology and bio-mathematics. He is also the single author of two books in Academic Press Elsevier.

#### Focus area: Economic landscape in SA

Prof Burger is the acting Dean for the Faculty of Economic and Management Sciences, a Professor of Economics and President of the Economics Society of South Africa. Until recently, he was Associate Editor of the South Africa Journal of Economics. In addition, he is a member of the OECD Advisory Panel on Budgeting and Public Expenditure. His publications include three books on fiscal rules and fiscal sustainability, public private partnerships and macroeconomic policy. He was seconded various times to the OECD in Paris to work on public private partnerships and capital budgeting, while in October 2011 he joined an OECD mission to Indonesia to conduct a regulatory review of Indonesia.

# Professor Robert Bragg

#### Focus area: Vaccine development

Prof Bragg and his research team from the Department of Microbial, Biochemical and Food Biotechnology are regarded as world leaders in their area of research. The team has been able to produce a vaccine against a virus which cannot be cultured. The technology is now used as a model for their other vaccine development projects. His main research focuses on the control of diseases, mainly in the veterinary field. Current research areas focus on infectious coryza in poultry, disease control in a post-antibiotic era and vaccine development. They are assisting vaccine producers in South Africa, India and Israel to improve the formulation of vaccines, and are investigating variant field isolates from countries in South and Central America. Resistance to disinfectants are also investigated.

## Focus area: Behaviour of atoms and molecules

Prof Conradie, professor in Chemistry at the UFS, research focus is the synergy between experimental and computational chemistry in understanding structure and reactivity of transition metal complexes. Her specific interest is computational chemistry. A super computer is used to study the behaviour of atoms and molecules in the real world. These reactions can be difficult and even dangerous. The research in the group focuses on the characterisation of known and unknown transition metal complexes and intermediates by synthetic and computational chemistry.

# **Professor Francis Smit**

Cardiac surgery has been revolutionised by Prof Francis Smit, Head of Cardiothoracic Surgery. He focuses on artificial heart-valve development and testing, bio-engineering of tissue used in cardiac surgery, adult and paediatric cardiac surgery. He and his team work towards decellularisation processes used on pericardium, heart-valve and whole-heart scaffolds for patents. The department boasts a sophisticated engineering laboratory, where heart-valve mechanics and fluid dynamics are tested on state-of-the-art pulse duplication and fatigue testing apparatus. The department is also home to the only homograft bank in South Africa where human valves are prepared and cryopreserved for transplanting and preservation.




## **Professor Corinna Walsh**

#### Focus area: Health and nutrition

Globally, it has become apparent that health in both children and adults is closely related to the early environment that children are exposed to during pregnancy and early childhood, says Prof Corinna Walsh of the Department of Nutrition and Dietetics and an NRF C-rated researcher. She has a keen interest in health research, specifically nutrition and health epidemiology. She has initiated three large-scale health and nutrition-related surveys that have been instrumental in determining the burden of disease in the Free State, related to both infectious diseases and lifestyle diseases. The morbidity and mortality resulting from these diseases have reached epidemic proportions in developing countries like South Africa, and are thus an important area of investigation. The focus of her research is on nutritional health, HIV, malnutrition, food security, and transitions from traditional to Western lifestyles and how these impact on health. Collaboration with co-workers from Basic Medical Sciences, Chemical Pathology, Haematology, Biostatistics, and others ensures a strong emphasis on interdisciplinary research.

This prestigious cross-disciplinary programme for the next generation of UFS professors (close to 60 scholars from five faculties) has produced to date the first UFS NRF P-rated scholar in 25 years, five NRF Y1-rated scholars, eleven Y2s and two C2-ratings; significant British Council Newton funding; Fulbright scholarships and a Commonwealth-funded scholarship, as well as a number of Erasmus Mundus-funded placements. The PSP has also produced successful Thuthuka applications, generating more than R10 million in student funding.

In the words of Prof Robert Morrell of UCT, underscored by a recent panel of A-rated scholars who reviewed the programme: "Within the South African academy, the PSP is a novel experiment in intellectual development and the development of professional scholars. It contributes towards positioning the University of the Free State as an innovator among research universities in the country."

## PSP priorities:

- · To provide a selected group of young scholars with advanced mentorship and development in three core areas of scholarship in higher education: discovery, teaching, and scholarship in public.
- To inculcate in these scholars the intellectual breadth and depth required to pose questions and generate knowledge over disciplines, and so to occupy the vanguards of contemporary intellectual enquiry.
- · To transform cultures of work among the scholars from those who lecture to those who profess.
- · To fast-track and establish the scholarly careers of these 'next generation professors' in the post-doctoral period of their careers through an advanced mentorship and development programme.
- To create and sustain rich international networks with leading universities and scholars in the world; networks within which the young scholars will be placed for purposes of mentorship, socialisation, networking and growth.
- To benchmark new and ambitious standards for the next generation professoriate in South Africa through this experimental programme targeting young scholars who have chosen academic careers for themselves.
- Through reflecting on the scholarly careers of those selected for the programme, help to re-imagine styles and trajectories of intellectual engagement for the university as a whole. In particular, to consider how approaches to scholarship at the UFS may emphasise social responsibility in knowledge production and transfer.

# **ETHICS**

Ethics is embedded in the research culture of the university. The questions we pose, the methodologies we use to gather data, and the ways that we write-up research findings all need to be informed by the greatest sensitivity to ethical concerns; in other words, being ethical is the foundation of good research.

Students and staff doing research are required to submit their proposals for ethical clearance to the relevant academic committee structures via RIMS.



# **SUPPORT**

You will be mentored and supervised by leading professors who are committed to developing your competence and confidence as a new researcher. Within your department and faculty, as well as through the Postgraduate School, you will be provided with the training and resources necessary to advance your thesis or dissertation. Of course the key person in your development as a researcher remains your supervisor and (where arranged) the cosupervisor. You will also find that fellow students often become key supporters in your learning as a postgraduate student.



# **FUNDING**

This university believes that postgraduate students ought to have as their first priority academic work rather than worry about financing their studies. We are therefore committed to postgraduate students and to find resources to support their studies. There is a dedicated office for postgraduate funding opportunities within the Postgraduate School to assist students in identifying sources of finance within and outside the university, and to prepare successful applications for funding. The office manages a rich online database of scholarships, bursaries and other funding opportunities.

The postgraduate office also offers individual consultations to students on questions related to financial support, and such meetings may be scheduled with Joy Nogabe.

# Payments prior to registration:

- Must be paid five (5) working days prior to registration.
- Students will not be able to register until these amounts reflect as credits on their tuition fee accounts.
- Account balances for 2018 must be zero.
- Should the tuition fees be less than the amounts required, the full amount is payable.
- International students: International students who register only for the second semester, must pay <u>all fees for the second semester</u> in advance before registration can take place.

# Students receiving financial aid (South African students only)

In cases where financial aid (bursary/loans) is received and covers <u>all</u> fees for the academic year, the amount payable in advance will be reduced by the amount of the financial aid. Proof of bursaries/loans must be faxed to +27 51 401 3579 or emailed to tuitionfees@ufs. ac.za five (5) working days prior to registration. The original proof of the bursary/loan must be presented upon registration.

In cases where the financial aid (bursary/loan) awarded to a student does not cover all the fees for the year, the prepayment as indicated above, remains payable five (5) working days prior to registration. The amount payable in advance must be reflected as a credit balance on the student's tuition fees account before the student will be allowed to continue with registration.

The attention of bursary holders is drawn to the fact that it is their responsibility to ensure that the bursary donors make payments timely and in accordance with university regulations. Bursars have to provide their sponsors with details of their accounts.

If a sponsor does not pay a student's account in time, interest will be charged and debited to the account, and the student will be responsible for the payment of such interest.

# Payment dates

Tuition and residence fees are calculated per semester. All fees must be paid as follows, regardless of whether or not an account was received. Official account statements are sent monthly to students' ufs4life email addresses. It is the responsibility of the student to supply the university with his/her correct contact details and to make enquiries should he/she not receive an account.

#### **South African students:**

- The prepayment as indicated must be paid five (5) days prior to registration.
- All fees for the first semester are payable on/before **31 March**.
- The tuition fee account must be settled in full by 31 August.

#### International students:

- The prepayment as indicated on www.ufs.ac.za must be paid five (5) days prior to registration.
- All fees for the first semester are payable on/before **31 March**.
- The tuition fee account must be settled in full by **30 June**.

All other fees are payable not later than the end of the month, following the month in which the transaction took place, as indicated on the account statement, unless specifically stipulated otherwise in the regulations.

- · All academic records will be withheld; and
- International students with outstanding fees on 1 July will not be allowed to continue with their second-semester studies.

# Library and Information Services (LIS)

The Bloemfontein Campus library has a dedicated Research Unit located on Level 6, creating a conducive studying/research environment for Master's and Doctoral students. The Research Unit is available during office hours only (07:45 to 16:30).

A multitude of electronic resources can be accessed on- and off-campus through the library's website. Information regarding off-campus access can be obtained from research librarians. Information resources can also be sent to students not residing in Bloemfontein (document delivery).

All library services (Bloemfontein, Qwaqwa, South Campus, Medical and Music libraries) are accessible for use by postgraduate students. Access is subject to positive identification with a valid student card.

Information/research librarians will contact prospective students for library orientation shortly after they have been registered as library clients. It is important for students to talk to their librarians as early as possible and be advised on the services and facilities offered by the library.

Postgraduate students can benefit from the Interlibrary Loans service (Level 6), which provides students with access to and use of books and journal articles not available in the library.

Postgraduate students can further benefit from familiarising themselves with the university's research output in the form of Electronic Theses and Dissertations (ETD) available on our website via Electronic Resources – http://etd.uovs.ac.za/cgi-bin/ETD-browse/browse

UFS LIS does not handle any cash. All students are required to load their student cards for photocopying and computer printouts. Please note that a waiting period of 48 hours is required before loaded funds are activated. The Cashier and Card Divisions are open from 09:00 to 15:00, Monday to Friday.

# SHORT GLOSSARY OF TERMS

# Dissertation

This is a full research report normally required for a research-based master's degree, and therefore does not normally include coursework. Please note that some universities use the terms 'dissertation' and 'thesis' interchangeably.

# **Ethical clearance**

This is the process all students' (and staff') research proposals have to pass through to determine whether the research satisfies the ethical standards for research, such as confidentiality and informed consent. Each faculty has a research ethics committee that has to approve all proposed research.

#### Honours degree

This postgraduate (after the first degree or first Bachelor's degree) degree prepares students for research-based postgraduate study and serves to consolidate and deepen the student's expertise in a particular field. This degree normally requires a minimum of one year full-time study or two years part-time study.

#### Master's degree

This postgraduate degree normally follows the attainment of an Honours degree and can be done through coursework with a dissertation (the mini-dissertation, with coursework) or through research alone (the full dissertation, no coursework). This degree normally takes one year of full-time study or two years of part-time study.

# **Doctoral degree**

This postgraduate degree represents the highest qualification in a university and normally follows the attainment of a Master's degree. A Doctoral degree is normally offered only as a research-based degree without coursework and is typically attained after four years of study. A Doctoral degree is normally referred to as a PhD (a research-based doctor of philosophy degree covering many fields, from the sciences to humanities) but sometimes a professional doctorate can be designated, such as a DBA (Doctor of Business Administration) or DEd (Doctor of Education).

#### Mini-dissertation

This is the short version of a full dissertation and normally forms part of coursework for a Master's degree, but could also be a requirement for an Honours degree or a postgraduate diploma.

# Postgraduate Diploma

This diploma is mainly available to students in the professions (such as nursing or teaching). It enables working professionals to undertake advanced reflection of their work in a specific area of specialisation. A research project is not required, but the diploma may include conducting and reporting basic research. This qualification requires a minimum of one year full-time study.

# Supervisor

A senior academic who guides the master's (dissertation) or doctoral student (thesis) from conception through the execution and submission of a research report. Sometimes the supervisor is assisted by a co-supervisor who has complementary expertise on the subject under study.

#### **Thesis**


A thesis is the full research report required for a doctoral qualification in which the student is required to make an original contribution to the body of knowledge in the field of study. The doctorate does not normally include coursework. Please note that some universities use the terms 'dissertation' and 'thesis' interchangeably.
