# Working with nature to build resilient communities

Mr Belle from DiMTEC organised a one day workshop on Disaster and the Environment on the 29 July 2015 at Villa Bali Hotel in Bloemfontein, South Africa. The theme of the workshop was "Working with nature to build resilient communities". The workshop was attended by about thirty delegates from diverse background but who have a role to play in disaster and environmental management.

During the general panel discussion on burning issues on DRR and the environment, key issues were

discussed, including:

The new A2R UN approach: Anticipate, Absorb and Restructure with greater emphasis on Resilience | Acid mine drainage | Implementing research results | Unsustainable development resulting in disasters | Climate change | Funding | Trained and skilled staff | Risk assessment | Ecosystem-based approaches to reduce disaster risk.

Disaster managers are challenged to think the unthinkable, especially under the present situation of climate change. A lot still needs to be done regarding training and effective utilising of disaster management departments, with an emphasis on building resilience.

# MHI Regulations and the Disaster Management Act

On 30 August 2015, Mr Alfonso Niemand, PhD student at DiMTEC, facilitated a workshop in Bloemfontein themed: A critical evaluation of commonalities and exclusions between the major hazard installations (MHI) Regulations and the Disaster Management Act in South Africa.

The workshop was attended by a strong selection of private sector and government officials with expertise in MHI and disaster management. Among the experts were delegates from DiMTEC, Ekurhuleni Emergency Services, Department of Labour, eThekwini Municipality Disaster

Management, eThekwini Municipality Emergency Serivces, Aurecon Group and TotalGaz.

Keynote speakers included Dr Jordaan from DiMTEC and Dusan Sakulski from the Office of the Premier, Free State.

The workshop deliberated both natural and humaninduced disaster, highlighting the critical importance of communicating with communities before, during and after a disaster that is currently prohibited by the National Key Point Act.

### **CENTENARY WORKSHOPS**

This is a legislation gap that needs to be addressed. Communities need to be educated about the risks posed by possible disasters with regards to preparedness, emergency response and recovery activities. Education of communities, are however, hampered due to high levels of illiteracy. Unfortunately, public information meetings does not serve the purpose intended.

Further topics arising from the workshop included: Transportation of hazardous materials | Working with tribal authorities | The Land Development Act of 2013 | Illegal land invasion | Communication with and liaision between stakeholders | Funding | Insurance.

A large part of the discussions centred on legislation with the conclusive argument that there are too many pieces of legislation in South Africa trying to govern the same safety issues.

### Media and Humanitarian workers

On 25 August 2015, Olivia Kunguma from DiMTEC facilitated a workshop in Durban themed: Building resilient communities through media and communication. The workshop was well attended and proved to be just what the humanitarian workers as well as media officials needed. Attendees included disaster managers, human development advisors, academics, emergency responders, journalists, corporates and police officers.

The following presentation formed part of the workshop discussions:

- South Durban basin: A classic socio-economic and environmental hotspot by Mr Chris Skinner.
- Crisis communication management is an integral part of business continuity management by Mr Dante Mashile
- Practical experience on response to displaced persons: Xenophobic attacks in the KZN Province by Mr Sibongiseni Negma
- Climate change and media by Mr Troy Govender

From the discussions following the presentation, the unreliable nature, but also the usefulness of social media during disasters were highlighted. Media representatives indicated that social media is a handy source of information when pressed for deadline. But if

the information cannot be confirmed, it will be published as a rumour. Press releases by humanitarian workers are often not preferred because it is used as a marketing tool instead of providing information.

Conclusively, it was emphasised that humanitarian workers should have sound relationship with the media. Furthermore, media and communication should be made part of all disaster management activities, from risk reduction to disaster response. Attendees requested the continuation of the UFS-DiMTEC workshop to allow annual dialogue between media officials and humanitarian workers throughout South Africa.

## **CENTENARY WORKSHOPS**

### Index-based insurance for the agricultural sector

A workshop titled "Global Resilience through Insurance and Index-Based Risk Transfer Products (IBRTP)" was organized as part of DiMTEC's 10th year celebration.

The United Nations identified climate resilience as a major focus for future development to ensure a safer world for all. Tailor-made insurance and financial products should address the needs of the most vulnerable. Recent research done by DiMTEC on the vulnerability of communal and commercial farmers to external shocks, highlighted the importance of insurance as an important disaster risk transfer tool. Insurance is generally unavailable to most vulnerable groups such as communal farmers, small-holder farmers and new commercial farmers. Therefore DiMTEC invited the insurance industry and other experts to a workshop with the purpose of investigating the development of risk transfer products, especially for drought.

Mr Bertus Kruger from Agriseker and Mr Johan vd Berg from SANTAM and other experts attended the workshop facilitated by Dr Jordaan from DiMTEC. Delegates agreed on the need for risk transfer products that address the needs of the most vulnerable. The private sector delegates confirmed their commitment toward the development of such products provided that Government actively support the initiative.

Delegates agreed on the following:

- Establishing a UFS-DiMTEC lead research team to investigate the feasibility of index insurance products.
- Mobilising government support to develop risk transfer products for the most vulnerable.
- Initiate forum discussions on risk transfer products.
- -Promote collaboration between private sector, government and research institutions with the focus on resilience building through financial and insurance products.
- Participation in COP 21 preparatory discussions in order to foster climate resilience through risk transfer products.

## **European visits**

Recently, Dr Jordaan visited several European cities to share his expertise, further relationships and negotiate research collaborations. Together with Prof Fransesco Zecca from the University of Sapienza, a visit was also paid to the University of Perugia. Areas of collaboration was identified.

Dr Jordaan also presented a paper at the Interdisciplinary Social Sciences conference in Split, Croatia, on social vulnerabilities of small-holder farmers to drought. Furthermore, ideas on flood and earthquake modeling were exchanged with the Vice-Rector at the University of Ljublnana in Slovenia.

Meetings with civil engineers who developed disaster risk and response models for floods and earthquakes, Prof Primuz Banovec and Mr Mathej Cerk, and the civil protection authorities in Slovenia and northern Italy were fruitful. Dr Jordaan visited the disaster management centre in northern Italy where the latest technology was demonstrated. This centre serves as a standby for the national centre in Rome and also serves as a regional centre for Slovenia.

The trip was concluded with a stop at the European Commission Joint Research Centre in Northern Italy.

### **UFS-DiMTEC in Oslo Norway**

Mr. Johanes Belle, a lecturer and researcher from UFS-DiMTEC, attended the 2015 International Environmental Emergencies Forum (EEF) in Oslo, Norway from 1 to 3 June 2015. This biannual international event was jointly organized by the United Nations Environmental Programme (UNEP) and the United Nations Office for the Coordination of Humanitarian Affairs (UNOCHA). The Forum brought together experts from all over the world on environmental emergencies to share experiences, network and map the way forward to better address environmental emergencies which are increasing in magnitude, intensity and frequency. During the Forum, the Green Star Award was conferred on three deserving winners.

#### **UN workshop on climate resilience**

During June 2015, DiMTEC director, Dr Andries Jordaan, was one of 23 experts – including scientist, academics, private, NGO and government officials – on the United Nation's expert committee at a workshop on climate resilience in Genève, Switzerland. The UN-secretary, Ban Ki Moon, invited Dr Jordaan to participate in this workshop as preparation for COP 21 later this year. "I have learnt a lot at the workshop," Dr Jordaan said, "and it was good to note that what we have been teaching our students for years is indeed the latest trend. The focus is much more on resilience than on vulnerability. Research showed us that it is better to focus on the positive. Even the poorest communities have the means to become more resilient against any disaster."

# Alice's corner: International migration—human coping and adaptation

I am busy with my PhD studies and, God willing, will complete it in the near future. My thematic areas are gender and women; coping and adaptation; human migration and security; and sustainable livelihoods. As part of the series on my thematic contribution, I will begin with international migration and human security. Human mobility is a reality. Globalisation and migration, which is as old as humanity, punctuates modern society. People's aspirations for a better life, and to an extent livelihood acquisition in the face of various exogenous depriving forces, drive mobility. Livelihoods are threatened by natural and man-made hazards like conflict and wars, especially in sub-Saharan Africa and recently the Middle East, Eastern Europe and Arab states, and North Africa.

People have always migrated to adapt to, or escape from difficulties and disasters, or by curiosity and dreams of a better life. What has brought particular attention to international migration in recent years is the scale and complexity of movements. It affects almost all countries around the world, catalysed by information flow speed, transportation options, and the increasing awareness of countless developmental opportunities and challenges that mobility offers to migrants, their families, communities and societies. Women participation during migration as a survival strategy, redefine women's role in the society and became a research interest.

International migration is no longer an individual country concern, but a global issue that calls for United Nations proactivity. Hosting migrants, short or long term, requires proper planning. Like Ban Ki- Moon said on the International migrant's day that:



"Migration is a reality of the 21st century. It is essential that we conduct an open debate on this important subject. Let us make migration work for the benefit of migrants and countries alike. We owe this to the millions of migrants who, through their courage, vitality and dreams, help make our societies more prosperous, resilient and diverse".

Migration must be part of the development agenda in all countries and policy makers should consider migration as part of their plans. In South Africa, it may be prudent that IDPs include migration issues. Due to globalisation and global change, migrants are found all over the world. The coping and adaptation capabilities and resilience capacity of these international migrants can be explored by seeking to answer the questions: Is it the various coping and adaptation mechanisms the migrant women bring from their home countries that enable them to make it in host countries, despite the various challenges they encounter? Is it the individual migrant's reaction to the migration related changes, which determine his/her personal wellbeing in a host country?
