INTRODUCTION

The Disaster Management Act 57 of 2002 addresses the shortcomings regarding disaster management in South Africa and puts the issue of disaster management in its rightful perspective. The new Act predominantly requires proactive planning and actions – mostly the responsibility of local authorities. Successful implementation of the Act depends on the capacity of local councillors and officials to recognise and understand the importance of disaster management as an integral part of sustainable development. The first step, therefore, in the implementation process is to build the capacity of all the necessary role players to execute the task at hand with confidence.

The growing realisation of the importance of disaster management around the world, in particular in South Africa, requires the disaster management fraternity to capacitate local communities in and around the country by sharing knowledge on disaster management amid the COVID-19 pandemic, which was declared a national disaster in South Africa more than a year ago. Therefore, UFS-DiMTEC invites anyone with an NQF Level 4 – all stakeholders interested in economic sustainability through exploring disaster risk reduction strategies – to register for this three-day short learning programme. With this short learning programme, UFS-DiMTEC aims to equip participants with in-depth knowledge about the South African Disaster Management Act 57 of 2002 (DMA), and how this legislation can aid COVID-19 risk reduction and ensure business continuity for economic sustainability. The title of the SAQA-registered and – accredited course is Introduction to Disaster Management (INDMI500S) and this year's theme is, 'For Risk Reduction, Knowledge is power'.

Target group – Disaster management practitioners, students, municipal officials, disaster management portfolio holders in various departments, and other role players in the disaster management environment, and any person interested to learn about disaster management.
