These include energy costs, inflation, interest rates, exchange rates, business cycles, taxes, and employment levels, among others.

Graduates who complete the Bachelor of Commerce with specialisation in Economics programme are prepared for careers in various sectors, including government, finance, and research, where a deep understanding of economic trends and their impact is highly valuable.
