<p><b>1. PREMISES</b></p> <p><b>PLEASE NOTE: ADMISSION IS SUBJECT TO SELECTION</b></p> <p>The present selection policy can be summarised as follows:</p> <ul style="list-style-type: none"> <li>(a) Any candidate can apply for admission to the first year of the MBChB programme (i.e. Grade 12 learners, school leavers, graduates and diplomates, and people who are already studying for a degree).</li> <li>(b) The progress of candidates who are already studying medicine at another university will determine at which stage of the UFS's MBChB programme the student will be allowed. Only in exceptional cases and with the recommendation of the Dean and approval of the School concerned, will a student be admitted to selection in another programme in this Faculty.</li> <li>(c) A holistic approach is important in the selection process, which is based on a points system that includes academic achievement, National Benchmark Test (NBT), cultural activities and sport.</li> <li>(d) A definite effort is made to accommodate candidates from a disadvantaged academic background who demonstrate the necessary potential and a reasonable ability to attain success in their course.</li> <li>(e) It is acknowledged that students and doctors are national assets, but students from certain areas in South Africa are regarded as the main responsibility of the UFS for possible selection.</li> <li>(f) A maximum target of 160 candidates (including 5 students from SADC countries, currently Lesotho) will be selected at a ratio of male 40% and female 60%.</li> <li>(g) Mainly South African students are selected for studies in the medical sciences due to the high costs involved in the training of such students. In respect of the SADC countries*, candidates will be selected in compliance with the policy agreement between the Department of Health and medical schools. (*Currently Lesotho; Botswana now has a medical school.)</li> <li>(h) Students from Namibia and Botswana are not part of the above agreement, but will be considered for selection if they have proof of permanent residence or are South African citizens and only very limited numbers.</li> <li>(i) Students are required to produce a medical report completed by a medical practitioner, as well as a completed health questionnaire.</li> </ul>	<p><b>1. (j)	The medical reports of applicants who have been selected for the MBChB programme will be provided to the Selection Committee to determine whether there are students with such disabilities that would make them unfit for medical studies. As far as the MBChB programme is concerned, immunisation against Hepatitis B is required beforehand and written proof needs to be provide at registration. The subject Life Orientation is not used in the calculation.</p> <p>(c) <b>Science Mark (WP)</b> is calculated by the average of the following: A minimum average mark on achievement level 5 (60%) is required for each of the following and is a compulsory prerequisite:</p> <ol style="list-style-type: none"> <li>1. Mathematics and</li> <li>2. Physical Sciences and</li> <li>3. Life Sciences</li> </ol> <p>(d) <b>Selection Mark (KP):</b> The maximum points to be attained by a student is 118 (academic achievement, and non-academic achievements in Grade 11 and 12). Of these points, 100 are allocated for academic achievement (weighting as follows: NSC:NBT = 60:40) and a maximum of 8 for non-academic achievements, a maximum of 8 for region of origin and 2 points for children of University staff or alumni. <p><b>2.2 Selection of learners who have already passed Grade 12 and are studying at a higher education institution, and graduates</b></p> <p>The Grade 12 marks attained by students who have already passed Grade 12 will be taken into account in addition to their post-school achievements at higher education institutions.</p> <p>Limited positions will be available for selection in this category.</p> <p><b>NBT tests</b> are compulsory for all applications. Students must fulfil the NBT requirements as set out under 2.1(e).</p> <p><b>2.2.1 University students</b></p> <p><b>(a) Degree not yet obtained</b></p> <p>For the selection of candidates who have completed one or more years of a programme that does not fall within the Health Sciences, the following apply:</p> <ul style="list-style-type: none"> <li>(i) A candidate will qualify for selection if he/she obtains a minimum average mark of at least 70% for the completed year.</li> <li>(ii) A candidate must have the minimum credits (full curriculum as set out in the regulations of the programme) required to pass a year of any programme.</li> <li>(iii) Preference will be given to students with an appropriate study field.</li> <li>(iv) Only students who have completed the first year of a mainstream qualification will be considered for selection (Students who are in extended programmes or bridging programmes will not be considered for selection).</li> </ul> <p><b>(b) Degree already obtained</b></p> <p>Selection of students who have already obtained a degree will be as follows:</p> <ul style="list-style-type: none"> <li>(i) Preference will be given to students with appropriate subjects with a minimum average of 70%.</li> <li>(ii) A candidate must have the minimum credits (full curriculum as set out in the regulations of the programme) required to pass a year of any programme.</li> <li>(iii) The programme must have been completed in no longer than the allowed minimum period plus one year.</li> </ul> <p><b>2.2.2 University of Technology and other Higher Education Institutions</b></p> <p><b>(a) Degree/diploma not yet obtained</b></p> <p>Selection of students from Universities of Technology and other higher education institutions will be done as follows:</p> <ul style="list-style-type: none"> <li>(i) A minimum average of 80% is required for completed modules.</li> <li>(ii) A candidate must have the minimum credits (full curriculum as set out in the regulations of the programme) required to pass a year of any programme.</li> <li>(iii) Preference will be given to students with an appropriate study field.</li> <li>(iv) Only students who have completed at least the first year of a mainstream qualification will be considered for selection</li> </ul>	<p><b>2.2.
