





It opened its doors in Bloemfontein in 1904 as the Grey University College, with six students in the Humanities. Today it is a multi-campus institution, with two diverse campuses in Bloemfontein and one in Qwaqwa in the scenic Eastern Free State, accommodating more than 40 000 students in its seven faculties (Economic and Management Sciences, Education, Health Sciences, the Humanities, Law, Natural and Agricultural Sciences, Theology and Religion), with an increasing number of international students and associates, and an ever-widening scope of active involvement in and contribution to its surrounding communities.

# DEVELOPMENT OF THE UFS CREST OVER MORE THAN A CENTURY



## 1904

Up to 1935, the same coat of arms was used as the Grey College School.



## 1935

By 1935, with the name change to University College of the Orange Free State, the coat of arms fell into disuse, especially among students.



## 1947

In 1947, an agreement between management and students led to the new motto Per Fidem ad Sapientiam (Through faith to wisdom).



## 1950

In 1952, it was changed to In Deo Sapientiae Lux (In God is the light of wisdom). The traditional orange, white and blue, linking the UFS to the South African national colours, changed in the late 1990s.

The orange was replaced by cherry red.



## 2011

The academic brand - the historic University of the Free State crest that has been the symbol of the university since 1952, has evolved to embrace the aesthetic expectations of the stakeholders.

The shape of the traditional academic shield has been simplified and contemporised. Much of the symbolism of the crest remains intact, acknowledging the location of the UFS brand as one of the country's premier institutions of higher education, with a proud history of academic excellence and an ever evolving, vibrant culture.



GLOVER, Michael John

Michael Glover was born in 1989 in Durban. He matriculated at the Roseway Waldorf School in 2007. He completed a BA with distinction in English Literature and Philosophy at Rhodes University in 2011 and a BA (Hons) in Philosophy with distinction in 2012. As a Mandela Rhodes Scholar, he completed a MA by thesis in History with distinction at the University of Cape Town. He completed a PGDip in Education Technology in 2018. In 2018 he became a lifetime Associate Fellow of the Oxford Centre for Animal Ethics. He has published in open pedagogies, animal and economic history, and philosophy.

With his thesis, titled: **CATTLE AND COLONIALISM: AN ANIMAL-CENTRED HISTORY OF SOUTHERN AFRICA, 1652-1980s**, Michael contributes to animal history in that – in a sustained way – cattle are presented as sentient subjects who were regionally impacted by colonialism. The thesis' primary question is: what are some of the major impacts of colonialism on cattle's experiences in southern Africa? The thesis uses an interdisciplinary approach and centres cattle as experiential subjects. Four major impacts are isolated. These are oxen's wagon labour, disease epidemics and veterinary and state responses to epidemics, the development of industrial slaughterhouses, and the development of modern colonial cattle breeding regimes. The geographical scope includes Botswana, South Africa, Lesotho, Eswatini, Namibia, and Zimbabwe. The investigation uses diverse historical sources. The core finding is that colonialism had transformative impacts on cattle history and experiences. The thesis contends that conceptions of colonialism should be widened to include its impact on animals.

Saima Nakuti Ashipala was born on 17 April 1985 in Omaandi, Namibia. She matriculated from the Namib High School in Swakopmund in 2002 and attained a Bachelor of Arts in History and Sociology from the University of Namibia in 2008. She graduated with a Master of Arts in History, also from the University of Namibia, in 2015 and also completed a Masters in International History from the Graduate Institute of International and Development Studies, in Geneva Switzerland, in 2015

With her thesis, titled: INTERNATIONAL DIPLOMACY AND BIG BUSINESS IN NAMIBIA: THE CASE OF THE RÖSSING URANIUM MINE, the candidate examined the counter-intuitive outcome of the economic dimension of Namibian decolonisation, through which a large multinational corporation with close links to the South African apartheid administration and whose operations in Namibia were the persistent target of nationalists and international campaigns survived the transition to independence virtually unscathed. The study presents the history of Rössing Uranium through the lens of big business and diplomacy in Namibia, providing a detailed understanding of the strategies adopted by big business in response to changes in the political and economic environment in Namibia.

Nobre De Jesus Varela Canhanga was born on November 28, 1973, in Quelimane-Mozambique. He joined Eduardo Mondlane University in 1996, graduating with a Bachelor's Degree in Political Science in 1999. In 2001, he graduated with an Honours



in Public Administration. In 2011, he joined the University of the Free State where he obtained the Bachelor of Arts Honours in Africa Studies in 2012 and, in 2013, completed his Master of Arts in Africa Studies. He currently lectures at Eduardo Mondlane University focusing on Local Governance, State and Governance, History of Political Ideas and Human Rights and Citizenship.

With his thesis, titled: DEMOCRATISATION AND STATE-BUILDING IN LUSOPHONE AFRICAN STATES: THE CASES OF CAPE VERDE AND MOZAMBIQUE, the candidate contributes to scholarship on the political dynamics of political transitions and democratisation in an African context. The candidate focused on an institutionalist approach in unpacking the dynamics that shape both good governance and socio-economic development with a focus on two case studies: Cape Verde, a relatively strong democracy in Lusophone Africa, and Mozambique, a hybrid regime in Lusophone Africa. His study was commended for engaging in an understudied area of Lusophone Africa, as well as raising critical questions on political trajectories and its influence on democratic consolidation or consolidating authoritarianism. The research was praised for engaging critical questions on factors that shape democratic reversal and strengthen democratic development. The candidate has contributed to the field of knowledge within democratisation and political dynamics in Lusophone Africa, and institutional dynamics within Africa.

Ruhan Fourie was born on 15 January 1993 in Uitenhage, After matriculating from Brandwag High School in Uitenhage, Ruhan Fourie completed his undergraduate BA studies at Nelson Mandela University in 2014. He completed his BA Honours (cum laude) at Stellenbosch University in the following year, whereafter he passed his MA in History (cum laude) in 2018 with his thesis covering the formative years of anti-apartheid theologian, Beyers Naudé. Hereafter he joined the International Studies Group at the University of the Free State as a PhD candidate.

With his thesis, titled: 'ANGELS AND DEMONS'? THE DUTCH REFORMED CHURCH AND ANTICOMMUNISM IN TWENTIETH CENTURY SOUTH AFRICA, the candidate explains why and how the DRC played a significant role in perpetuating an anticommunist imagination amongst twentieth century Afrikaners. Drawing from the most recent theories on anticommunism, this thesis decentres the state and further expands the dynamics of South African anticommunism beyond a Cold War-paradigm and embraces the flexibility of the phenomenon. It offers an original account of South African anticommunism by integrating a wide range of archival sources of key role-players and organisations into a single chronological narrative. This thesis ultimately argues that the DRC formed the backbone of Afrikaner anticommunism throughout the twentieth century and concludes that Afrikaner anticommunism functioned as a vehicle for nationalist unity (and uniformity), a paradigm for shaping Afrikaner identity, and a legitimiser of the volk's perceptions of its imagined moral high ground.

Sarudzai Chipo Mutsa Mahomva matriculated at the Dominican Convent High Scholl in Harare and obtained a BA Honours (Digital Media) cum laude and a MA (Information Technology in Higher Education) from the University of KwaZulu-Natal. She also obtained a MA (Gender Studies) cum laude from the University of the Free State.

With her thesis, titled: CAREGIVING - A FEMINIST PERSPECTIVE ON THE LIVED EXPERIENCES OF CAREGIVERS IN HARARE, the candidate looked at the provision of care to the elderly in families in present day Harare. Since people live longer in modern times, her findings have increased relevance for the different spheres of life. A merit of the findings is that previous studies focused mainly on hegemonic forms of masculinities and neglected other forms as identified in this study.



Sarudzai managed to incorporate different theoretical frameworks into the data analysis process. The candidate demonstrated the ability to discuss findings systematically, in a coherent and logical manner, contributing to the body of knowledge in gender studies.

Teboho Molete was born in Bloemfontein on 28 January 1967. He received his secondary education in Bloemfontein, where he matriculated at Lekhulong Secondary School in 1986. He obtained a BA ED and BA Honours (History) degree from the former Vista University in 1991 and 1995 respectively. In 2007, he obtained a Master's degree in International Studies from Rhodes University. He started his career as an educator in Bloemfontein in 1992 and became a school deputy principal in 2002. In 2010, he was appointed in the Department of Political Sciences at UNISA where he is currently a lecturer of International Politics.

With his thesis, titled: THE SECURITY-DEVELOPMENT NEXUS IN POST-CONFLICT AFRICA: A DECOLONIAL CRITIQUE WITH REFERENCE TO SIERRA LEONE, the candidate makes a significant theoretical and empirical contribution to the fields of security and development, as well as the nexus between them, through the application of decolonial theory to the case study of Sierra Leone. The study examines why reconstruction and development processes in post-conflict African states like Sierra Leone, pursued with the security-development nexus, have been frequently unsuccessful. Moving beyond a mere critique of the coloniality of liberal peacebuilding approaches to security sector reform, the candidate demonstrates a nuanced understanding of both the strengths and limitations of this body of literature. The candidate challenges the conflation of security and development in theory and practice, and frames decolonised security, decolonised development and a decolonised security-development nexus as alternative conceptualisations that are Africa-centred, more suited to the African post-conflict situation, and premised on the concerns of local people rather than states.

### SANTEBE, Mbozi

Mbozi Santebe was born in Zambia's Mulobezi District on 24 July 1979 where he received his secondary education, matriculating from Sichili Secondary School in 1997. He obtained a Diploma in Secondary Education from Nkrumah College of Education in 2001, followed by a Bachelor of Arts with Education in 2012 and a Master of Arts in History in 2015 from the University of Zambia. His career began in 2001 as a secondary school teacher in Mpika. He was later appointed as a Lecturer in History at the University of Zambia in 2016, a position he currently holds.

With his thesis, titled: A HISTORY OF THE PRODUCTION OF STATISTICS IN ZAMBIA, 1939-2018, the candidate contributes to scholarly understanding of statistical development in Zambia. Using archival and oral sources, the thesis reveals the external and internal dynamics that shaped the making of numbers. External forces such as British colonial rule, and later, international organisations and donor institutions, shaped data priorities, funding of enquiries and the formulation of concepts, methods and classifications used to produce statistics. Yet, internal dynamics also played a role as the local environment determined the availability of requisite data, the application of international frameworks and the implementation of statistical reforms. The thesis argues that the development of statistics, and their quality, was uneven across subjects and time. Often, inadequacy of requisite data weakened statistics and adversely affected policy making, service delivery and development programmes.

#### TEMBO, Emmanuel Tavulyandanda

Emmanuel Tembo was born on 18 November 1967 in Lubero, North-Kivu, DR Congo. He matriculated at Mulo Secondary School in 1985. He later underwent a priestly formation and obtained a degree in philosophy at the Major Seminary of Goma (1989) and in theology at the Facultés Catholiques de Kinshasa (1994). In 2007 he joined the Catholic University of Eastern Africa in Nairobi where he obtained two masters degrees in Canon Law (2010) and in International Relations and Peace Studies (2013). Before he embarked on his doctoral studies, he had been teaching at the Marist International University College in Nairobi, Kenya.

With his thesis, titled: INTERETHNIC CONFLICT AND THE ROLE OF TRADITIONAL LEADERS IN THE TRUTH AND RECONCILIATION PROGRAMME IN NORTH KIVU, DEMOCRATIC REPUBLIC OF CONGO, the candidate contributes to scholarship on addressing the gap over the traditional leaders' role in the truth and reconciliation programme designed to guell the interethnic conflict in North Kivu province. Using a qualitative approach, Tembo sampled 101 participants in North Kivu to understand and add the voices of traditional leaders to the debate on the normative processes of truth and reconciliation. This research raises issues that are important for peacebuilding—the need to involve traditional leaders in peace processes at grassroots levels—especially in the rural communities where they have significant influence and authority over their subjects. The study presents argument that a holistic peace approach, where the input of other actors is needed, is required to foster good governance, security cooperation and education for peace.

Chris Vorster was born in Pretoria on 24 March 1970. He received his secondary education in Cape Town, where he matriculated at D.F Malan High School in 1987. He obtained the degree B.Dram in 1994 and M.Dram in 1998 at the University of Stellenbosch. He started his career as an actor-director in Cape Town in 1995 and joined the soap opera 7de Laan in 2000. In 2015 he was appointed in the Department of Drama and Theatre Arts and at present he is a film and television lecturer at the University of the Free State.

With his thesis, titled: 'N PRAKTYKGEBASEERDE PERSPEKTIEF OP FRANZ MARX AS DIE SENTRALE FIGUUR IN DIE ONTSTAAN VAN DIE EERSTE AFRIKAANSE TV-DAGVERVOLGVERHAAL, the candidate contributes to the existing historical records on Franz Marx's extensive career and the origin of daily serial dramas and soap operas in South Africa. The study is divided into two separate sections, each with different objectives. In Section A an exposition of the various factors that influenced and equipped Marx as an artist for the creation of the first Afrikaans TV daily serial drama - Egoli: Place of Gold – is presented. This study is placed within the methodology of practice-based research and utilises this method to acquire and verify information concerning Marx as the central figure in the conception of the first Afrikaans TV daily serial drama. Various South African film and TV practitioners assist in contextualising Marx's influence within the local entertainment industry. International and South African literature further contextualises Marx's contribution and puts his creative methodology in perspective. Section B, the creative writing component, comprises an Afrikaans telenovela-hybrid, Skietstilstand. The narrative is based on a small production team struggling to film a new situational comedy (sitcom). To create the telenovelahybrid, the melodramatic storylines and relationship intrigue associated with soap operas are combined with the unique characters and situational incidents linked with and to sitcoms. This series can also be read as a parody of the soap opera genre.

Daudi Kipkemoi Rotich was born in Bomet, South Rift, Kenya, in 1978. He completed secondary school education at Kabianga High School in 1995. He obtained a Bachelor of Education (Arts) Degree in Linguistics and Literature in 2001 at Egerton



University and a Master of Arts (Literature) in 2011 at the University of Nairobi. He taught high school English from 2002 to 2009. He served as the Programmes Officer at the Kenya Oral Literature Association (KOLA) between 2011 and 2013. He is currently teaching Literature and English Language at the University of Djibouti (Djibouti).

With his thesis, titled: **TRANS-MEDIATING NATIONHOOD IN THE IMAGININGS OF THE NEW PAN-KALENJIN CO-PRESENCES**, the candidate contributes to scholarship on the intersection between cultural performances and historical trajectories in the production and sensing of changes of ethnic nationhood in Kenya. The study, which draws largely on Turner's concepts on social drama, focuses on daily lives, cultural performances and textualities on nationhood to examine the nature and effect of the post-Moi Kalenjin pan-ethnic nationhood. It argues that the Kalenjin nation that is ushered by the end of Moi's presidency can be understood from the angle of trans-mediated processes constituted within the Kalenjin psyche, sense of self and performances in the Rift Valley and in their relations with Kenyans of other ethnic groups in the region and nation at large. Thus, Rotich's findings provoke serious consideration of the cultures, performances, imaginaries and daily lives, which he terms everyday co-present activities of a community that constitute national dramas, and the function of the past, in determining ways in in which nationhood is (re)construction in Kenya and by extension in the rest of Africa.

With his thesis, titled: AN ANALYSIS OF EMERGING GOVERNING COALITIONS AT THE LOCAL LEVEL IN SOUTH AFRICA WITH A SPECIFIC FOCUS ON JOHANNESBURG AND NELSON MANDELA BAY, the candidate makes a valuable contribution to the field of Governance and Political Transformation. The study demonstrates that the efficacy or inefficiency of governance of these two metros are measurable in order to arrive at tangible evidence of whether these coalitions have led to good governance or not. With this contribution, he determined whether the emerging coalitions involved have contributed to good governance and which factors present in these coalitions influenced governance in these metros. This study also contributes to the body of knowledge by contrasting a European phenomenon with what transpires on the local level in South Africa and has determined that coalition theories emerging from Western Europe are insufficient to explain theorisation of social division factors that are unique to South Africa.

The study demonstrates that unemployment among the youth in South Africa is high and that this has a direct bearing on poverty levels and standards of living. With this contribution, she attempts to determine the effectiveness of South African youth development policies in ensuring development and empowerment, particularly with regard to employment. The study identifies various challenges pertaining to the implementation of relevant youth policies. In addition, it focuses on developing a strategy to address these challenges facing youth and attempts to synergise the policy implementation process for efficiency and accountability in governance. The study concludes that network governance should be applied in South Africa and is necessary to address youth unemployment from a collective worldview.

With his thesis, titled: WHITES AND THE LIBERATION STRUGGLE IN THE ORANGE FREE STATE AND TRANSVAAL, 1953-1994, the candidate focuses on the whites' involvement in South Africa's liberation struggle with specific reference to the Orange Free State and Transvaal. It encompasses a period from the 1950s to the 1990s and considers the way regional histories have been marginalised from the broader liberation historiography. It challenges the narrative that the struggle for the country's liberation was the domain of only black South Africans, with a limited role played by the white political activists within the liberation movements/organisations. It adds a new dimension to the growing liberation history scholarship by offering a regional and local perspective to the political developments in the period under discussion. It recognises the contribution of these 'pockets' of white progressive liberals and their organisations, as well as those extreme liberals who operated outside of the main party-political strata. It also considers the political construct of whiteness and how it impacted the struggle for liberation.

#### DOCTOR OF PHILOSOPHY WITH SPECIALISATION IN LINGUISTICS

#### HALA HALA, Mokhoele Aaron

Mokhoele Aaron Hala-hala holds a BA Hum in English and Linguistics and Theology (Double Majors) from NUL, a BA Hons in Applied Language Studies in English from UFS and an Mphil Ed in Applied Language and Literacy Studies from UCT. He is a Senior Lecturer in the Department of English, Faculty of Humanities, at the National University of Lesotho. He has been teaching courses such as academic literacy and professional communication, discourse analysis, pragmatics and editing and publishing at NUL. His research interests cover academic literacy, critical discourse analysis, sociolinguistics, world Englishes as well as journalism and media studies.

With his thesis, titled: **SOCIOLINGUISTICS OF LESOTHO ENGLISH IN THE KINGDOM OF LESOTHO**, the candidate contributes to the sociolinguistics of World Englishes. In this qualitative study, the candidate analyses phonological, morphosyntactic and lexical features of Lesotho English in a variety of both spoken and written sources. With the purposively



selected sample of 87 texts, both spoken and written, the candidate has also drawn on variationist sociolinguistic theories and the Kachruvian plurocentric English paradigm. He found systematically salient patterns of Lesotho English at the phonological, morphosyntactic and lexical levels. On this basis, he concludes that Lesotho English could be seen as bearing both nativised, endonormative and exonormative variations of English. While some of these particular variations noted for Lesotho English could be viewed as marking idiosyncratic, innovative and/or stabilised variants of the sociolinguistics of Lesotho English in Lesotho, they are significantly comparable to other outer-circle and inner-circle Englishes.

#### DOCTOR OF PHILOSOPHY WITH SPECIALISATION IN PHILOSOPHY

#### **DENIS**, Nathne Alice

Nathne Alice Denis was born in Cathcart on 9 September 1969. She received her secondary education in Graaff-Reinet and Uitenhage where she matriculated at Riebeek College Girls High School (Uitenhage) in 1987 as the Dux Scholar. She obtained the degree B.Mus with distinction in 1993 and the degree M.Mus in 1998. Nathne taught music at Victoria Girls High School in Grahamstown in 1994 and subsequently lectured in the School of Music at the Nelson Mandela University, before registering for a PhD. At present she is working on a Post-Graduate Certificate in Education through Rhodes University and writing articles for publication.

With her thesis, titled: MARABI AND POSTSTRUCTURALISM(S): AN INQUIRY INTO THE POSSIBILITY OF FORGING A RAPPROCHEMENT BETWEEN ASPECTS Of POSTSTRUCTURALIST THINKING AND MARABI IN ITS CONTEXT (1920'S-1930'S), the candidate attempts to bring together two seemingly incompatible opposites, namely aspects of the poststructuralist thinking of Deleuze, Guattari, Derrida, Cixous and Foucault, on the one hand, and marabi, on the other, the slumyard music (inter alia) of Johannesburg in the 1920s and 1930s in its context. Specific attention is paid to the crucible of suffering and privation out of which marabi was wrought. Using different forms of reason, it was found that these strange bedfellows are not only highly compatible, but also offer a more nuanced way of thinking about marabi in all of its rich, multitudinous and resilient guises, as well as serving as a useful critical prism through which aspects of poststructuralism can be refracted and rethought.

#### VUNZA, Joao Pedro Mbay

Mbay Vunza was born in 1962 in Mbanza Kongo, and he matriculated at college Ntemo in 1981 in Kasongo Lunda (DRC). He studied at Gregoriana University (Italy) and completed his BA Philosophy degree in 1986. He studied at the University of Limpopo and completed his Honours degree in 1995, and his Masters in 1999 both in Philosophy. Since 1996 he has been working at the University of Limpopo as a Lecturer in Philosophy.

With his thesis, titled: BAD FAITH AND UNDERDEVELOPMENT IN AFRICA: THE CASE OF THE DEMOCRATIC REPUBLIC OF CONGO, the candidate focuses on the legacy of developmental failures in post-colonial Africa. In consequence, many are understandably aware of this African condition that seems to continue without end. In this current situation, one can only ponder if Africa will remain impoverished forever, or should we have faith and hope that the situation might change for the better? This study attempts to address these issues by offering an existential-phenomenological interpretation of bad faith (mauvaise foi) in the African situation. This study not only analyses this Sartrean concept of bad faith at its various levels, but



also aspire to search how this attitude can be practical in the African context of development and underdevelopment – and more specifically in the context of the Democratic Republic of the Congo (DRC).

#### DOCTOR OF PHILOSOPHY WITH SPECIALISATION IN POLITICAL SCIENCE

SCHOEMAN, Petrus Albertus

Albert Schoeman was born on 5 May 1971 in Evander. He received his secondary education at Schweizer-Reneke High School where he matriculated. He obtained a Bachelor of Arts (1993), Bachelor of Arts Honours (1994) and Master of Arts (1996) degrees from the University of the Free State. He was appointed as a lecturer in the Department of Political Science at the Qwagwa campus of the University of the North from 1998 until 2004 when the campus was incorporated into the University of the Free State. Since 2004 he has served as lecturer and later Subject Head of the Department of Political Studies and Governance at the University of the Free State (Qwagwa campus).

With his thesis, titled: BEYOND THE STATE CENTRIC LENS OF THE FRAGILE STATE DISCOURSE - THE CASE FOR HYBRID POLITICAL ORDERS IN SOMALILAND, the candidate contributes to the scholarship of a post-Western, revisionist and alternative perspective on current state-building practises by emphasising the role of a Hybrid Political Order, as such an alternative form of state-building, in Somaliland. Current IR theory, with a particular emphasis on statehood, the fragile state perspective, and state-building, is accused of being exclusive and catering to the needs of small elites and excluding the rights and contributions of the majority of the world population. Rather than exaggerating the politics of public bodies, the candidate argues that Political Science and IR theory should place greater emphasis on people and politics at grassroot level during state-building endeavours.

## DOCTOR OF PHILOSOPHY WITH SPECIALISATION IN SESOTHO

NHLAPO, Moselane Andrew

Moselane Andrew Nhlapo was born on 28 April 1992 in Mashaeng (Fouriesburg) in the Free State Province of South Africa. After he had obtained his Senior Certificate at Ipokelleng Secondary School in 2009, he studied at the University of the Free State (UFS), where he received his BA degree in 2013. He then continued his studies at the UFS, where he completed an honours degree in African Languages in 2014 and a master's degree in 2015. He started tutoring at the department of African Languages in 2015, after which he joined the department of African Languages at the UFS as a junior lecturer on a contractual basis in 2016. Currently, he teaches Sesotho Home Language to first and second-year students.

With his thesis, titled: HISTORICAL PERSPECTIVES OF THE DEVELOPMENT OF SESOTHO LINGUISTICS WITH REFERENCE TO SYNTACTIC CATEGORIES, the candidate contributes to the scholarship of African Languages Linguistic Studies with his thesis titled 'Historical Perspectives on the Development of Sesotho Linquistics with reference to Syntactic Categories'. The study has explored the general characteristics of a particular linguistic period to determine the extent to which the linguistic status and the development of Sesotho syntactic categories align to the empirical linguistic periods, as well as the extent to which these categories have changed over time. The candidate followed a descriptive research design using Crowley's (1997) comparative method on historical linguistics. The study has found that the analysis of grammatical phenomena at different times in the history of African Languages was patterned and classified according to European classical languages and according to prominent characteristics of a particular linguistic period, despite their unique grammatical structures. However, the arrival of modern linguistic approaches that filtered through at a later stage, has enabled the study to recognize the uniqueness of syntactic categories in African Languages – a uniqueness that has brought them back into their spaces of history and which has secured their lost identity.

#### DOCTOR OF PHILOSOPHY WITH SPECIALISATION IN SOUTH AFRICAN SIGN LANGUAGE AND DEAF STUDIES

BRUWER, Beausetha Juhetha

Beausetha Bruwer was born on 18 March 1982 in the Hardap Region of Namibia. She matriculated at Dr. Lemmer High School in 1999 and attained her Bachelor of Education degree at the University of Namibia in 2004. In 2009 she obtained her Honours degree in Language Studies at the University of the Free State and in 2013 she obtained her Masters in Language Studies at the same university. She started her career as a relief teacher for deaf learners and later became part of the lecturing staff at the Windhoek College of Education and then University of Namibia.

With her thesis, titled: THE IMPLEMENTATION OF A BILINGUAL-BICULTURAL LITERACY INTERVENTION PROGRAMME FOR DEAF LEARNERS IN NAMIBIA, the candidate explored the best instructional practices to teach deaf learners through the Bilingual-Bicultural Literacy approach, the policy position adopted by the Namibian education authorities. This was done through designing, testing and implementing an intervention programme that can narrow the delay and gap in language learning and literacy. The programme involved designing integrated planning manuals based on Namibian Sign Language (NSL) and Written English syllabuses, as well as appropriate teaching and learning materials and the training of teachers involved in the study. The implementation of the programme made a positive impact on and a significant improvement in the biliteracy of the participating deaf learners. The teachers developed new teacher attributes in the form of self-efficacy, the ability to communicate in NSL, experience and skills to teach deaf learners and good teacher-learner relationships.

## The Main Procession Graduation Gowns



outh Africa, and the Free State in particular, has a long-standing friendship with our neighbouring country, Lesotho.

Through a shared history, we have become co-creators of our futures. For this reason, the UFS decided to incorporate our tradition with that of the Basotho in the design of our Main Procession graduation gowns.

The gowns are inspired by the Seanamarena – the traditional Basotho blanket. The different patterns on the Seanamarena indicate the status one holds in the Basotho nation or reflect the occasion being celebrated. Keeping the Seanamarena pattern in mind, we combined our traditional academic designs with that of the Basotho nation.

## YOKE PATTERNS



## Yoke pattern for the Chancellor and Vice-Chancellor

This Seanamarena pattern is an interpretation of a design – used exclusively for the king and chiefs – which means 'to swear by the king'. This blanket has the highest status of all Basotho blankets.



## Yoke pattern for the Chairperson of the Council

This Seanamarena Victorian crest motif appeared after the visit of the Prince of Wales to Lesotho in 1925, which made a profound impression on the local people. Customers refer to this blanket as 'lesiba' – meaning feathers – when buying it.



## Yoke pattern for the Vice-Rector

This Seanamarena Poone design symbolises good crops, wealth, and fertility. The Poone is given as a present to honour an important visitor.



## Yoke pattern for Registrar

The same Seanamarena Poone design used for the Vice-Rector applies to the Registrar, with some slight design and colour alterations.

The Deans wear gowns made in the colours of the faculties, or others which indicate the office they hold.
