IMPORTANT INFORMATION

- 2018 Account balances must be zero.
- First payments are due five (5) working days prior to registration. Students will not be able to register until these amounts reflect as CREDITS on their tuition fees accounts.
- The full amount is payable when the total fees are less than the first payment required.
- Students studying with financial aid (bursary/loan) (SA students only):
 - If the financial aid (bursary/loan) does not cover all the fees for the year, the first payment is payable five (5) working days prior to registration. Failure to do so, will delay registration;
 - Should the tuition fees be less than the first payment required, the full amount is payable;
 - If the financial aid covers all the expenses for the full academic year, then the first payment will be reduced by the amount of the financial aid;
 - Should a student qualify for a UFS merit reward, it may be used as partial/full payment of the first payment.
 - Proof of financial aid must faxed to +27 51 401 3579, five (5) working days prior to registration. The ORIGINAL PROOF of the bursary/loan must be presented during registration;
- First-year students are reminded to have their parent/guardian/other third party complete and sign the Financial Agreement, which was sent during 2018. Students must upload the document as per the instructions or alternatively email the documents to tuitionfees@ufs.ac.za as soon as possible prior to registration. Failure to do so, will delay registration.
