

# FIRST PAYMENTS FOR REGISTRATION 2018

**1. 2017 account balances must be zero.**

2. First payments are due **five (5) working days prior** to registration. Students will not be able to register until these amounts are reflected as CREDITS on their tuition fees accounts. Should the tuition fees be less than the first payment required, the full amount is payable.

**3. Students studying with financial aid (bursary/loan) (SA students only):**

3.1 If the financial aid (bursary/loan) does **not** cover **all** the fees for the year, the first payment is payable **five (5) working days prior** to registration. Students will not be able to register until these amounts are reflected as CREDITS on their tuition fees accounts. Should the tuition fees be less than the first payment required, the full amount is payable.

3.2 If the financial aid covers all expenses for the full academic year, then the first payment will be reduced by the amount of the financial aid.

3.3 Proof of financial aid must be faxed to 051 401 3579 five (5) working days prior to registration. The ORIGINAL PROOF of the bursary/loan must be presented upon registration.
