

PAYMENTS PRIOR TO REGISTRATION 2017

1. 2016 account balances must be zero.
2. Prepayments are due **five (5) working days prior** to registration. **Students will not be able to register until these amounts are reflected as CREDITS on their tuition fees accounts.** Should the tuition fees be less than the prepayment required, the full amount is payable.
3. **Students studying with financial aid (bursary/loan) (SA students only):**
 - 3.1 If the financial aid (bursary/loan) **does not** cover all the fees for the year, the prepayment is payable **five (5) working days prior** to registration. **Students will not be able to register until these amounts are reflected as CREDITS on their tuition fees accounts.** Should the tuition fees be less than the prepayment required, the full amount is payable.
 - 3.2 If the financial aid covers all expenses for the full academic year, then the prepayment will be reduced by the amount of the financial aid.
 - 3.3 Proof of financial aid must be faxed to 051 401 3579 **five (5) working days prior** to registration. The **ORIGINAL PROOF** of the bursary/loan must be presented upon registration.
