Only students where confirmation from the Faculty is received will be considered for funding.
2. Only academically deserving students can qualify where the average percentage for your studies at UFS is not less than 60%.

REQUIREMENTS FOR STUDENT LEADERS:

1. Members of the Student Representative Council, residence committee members or sub-wardens who are academically deserving may apply. Financial Aid will obtain confirmation from Student Affairs that the student is a student leader.
2. Only academically deserving students can qualify where the average percentage for your studies at UFS is not less than 60%.

CONDITIONS

1. The Monitoring bursary will not cover any fees for the current year of study. This funding will only cover outstanding fees from the previous year of study, from the minimum of R2000 upwards.
2. Only one Monitoring Committee bursary can be granted during an academic career.
3. NSFAS payable amounts or any other amounts unrelated to historic tuition fees will not be covered by the Monitoring bursary.
4. The Monitoring bursary may be reduced or cancelled if your application was successful and you received another source of funding which cover the outstanding fees.
5. An allocation can only be made if you are term activated by Student Academic Services for the year.
