The President chaired the meeting

Point 1 – Spirit Cup logistics (Keneilwe)

Date: 8 March 2024

- Discussion of the prize that the res will win (Harmony Trophy).
- The Council will have to fund the house wins. An amount of R8 000 was suggested by the Treasurer, and the Council took a collective decision not to fund the event in the form of money because some of the projects the SRC planned did not find expression, so it makes no sense.
- The SRC will be responsible for the sound system and other things (transport, trophy, SRC meal packs, and a house certificate).
- The MC will be out-sourced (Moloko was proposed by the SRC).

Point 2 – Evacuations of unregistered students from on-campus residences (Luzuko)

- A suggestion of a three-day extension of students' stay on campus was raised to the res heads, along with another suggestion that the SRC uses its entity to pay for at least two students.
- Requesting an update from UFS Housing and Residence Affairs (HRA) as to how they are dealing with the student evacuations, especially on weekends, bearing in mind that some of the students don't have the means to go back home.
- The SRC then took a decision to reach out to FinAid to speed up the res deposit refund.
- The SRC will reach out to Ms Lee to extend the stay of students who are not registered to this coming Monday after 12pm.

Point 3 – EMS Faculty appeal outcomes (Lizzy)

- Some students have not received their outcomes, so they can't continue with the current year's modules.
- Appeal outcomes are dealt with frequently in a meeting by the committee.
- **SRC Academics** will write to the faculty to request an update on the issue of finalising appeals.



- Unregistered students without qualification obtained and those without allocations as yet (Lizzy)/
- students who wrote the special exam and have not received their results: **President/Martin** will follow up.

Point 4 – Allowance disbursement clarity (Lizzy)

- Meal packs (one or two per day) will be given to all students until Friday, when the meal allowances are allocated.
- The Secretary explained that the allocations will be made by the institution this coming Friday.
