## **BACKGROUND**

The University of the Free State (UFS) is providing partial funding for research-related costs for registered master's and doctoral students. The funds are to be used for the collection of primary data for the purpose of meeting a specific research goal for the final presentation of the research. Funds are awarded on a competitive basis and depend on the availability of funds at the time of application. The research conducted must adhere to all university requirements, including policies related to the ethical conduct of research. Application forms are to be submitted at least eight weeks before the fieldwork is scheduled to take place to allow for timeous processing.

## **ELIGIBILITY**

- Students must be registered for master's or doctoral studies.
- Students must have received research ethics approval.
- Master's students are eligible for research funding within the first two years of registration.
- Doctoral students are eligible for research funding within the first three years of registration.
- Students must demonstrate that all relevant UFS requirements relating to research have been met.
- Students must submit a detailed timetable for research-related travel.
- Students must provide a satisfactory progress report.
- Students must provide information on the rationale for the study, aims, objectives, and methods to be employed.
- Meeting the eligibility criteria does not guarantee a successful application. Funds are awarded on a competitive basis and depend on the availability of funds at the time of application.
- Retrospective applications are not permitted.
- Applications must be supported by the student's supervisor.

## **FUNDING**

- A maximum of R4 000 may be awarded to master's students.
- A maximum of R8 000 may be awarded to doctoral students.

Budgets are expected to be prudent and economical, and budget items may be funded at lower levels than requested. The CGS may choose to award less than the allowable maximum, depending on the quality of the application and available funds.

If for any reason the research is abandoned or is unsuccessful, the student must inform the CGS within one calendar month to recover the research funds utilised towards the study.

Preference will be given to students who are unable to access alternative funds for research support.

**Please note the following:**

- The funding approval is not transferable to another applicant or study.
- Service providers will be paid directly, and **no** payment will be made into the student's bank account.
- Funding recipients must submit a progress report at the end of each academic year.
- Each application is assessed on its merits.
