2. PARTICULARS REGARDING THE DONOR 1)

Willem Jacobus Petrus Carr, a descendant of the British Setlers from Clan William, attended school in Johannes-burg and studied history and economics at the Witwaters-rand University.

During 1925 he was appointed as location clerk in the Native Affairs Department of the Johannesburg City Council. This department later became known as the Non-European Affairs Department. On the outbreak of the Second World War, he volunteered for active service and on demobilization he resumed his normal duties. He was appointed as head of his department in 1945 and served in this position until his retirement during 1969.

3. THE DOCUMENTS AND THEIR ARRANGEMENT

3.1 ORIGIN

The collection was handed over to the Institute for Contemporary History in instalments by Mr. Carr, during 1975 and 1976.

3.2 ARRANGEMENT

The documents of Mr. Carr are fairly complete and reflect the wide range of his interests and activities, especially regarding the administration of black townships.

The collection consists mainly of subject files, but a few loose documents also exist.

A subject classification is maintained with an indication of the kind of material for each file. Where possible, series are divided into sub-series to assist the researcher. Files of clumsy proportions are sub-divided.

Loose documents are sorted into series according to the kind of document. In all cases documents are arranged chronologically within each series. Undated papers have been placed at the end of each relevant subject.
