### THE HEART OF SOUTH AFRICA

The Free State lies in the centre of South Africa, bordering the Northern Cape, Eastern Cape, North-West, Mpumalanga, KwaZulu-Natal, and Gauteng, as well as Lesotho.

Known for its good soil and climate, the Free State produces more than 70% of the country's grain and offers astounding scenic beauty. Its wide, open plains are laced with the spectacular Drakensberg and Maluti mountains to the east of the province. The popular Golden Gate Highlands National Park boasts spectacular sandstone cliffs and is rich in San rock art. You can also view wildebeest, eland, blesbok, oribi, springbok, Burchell's zebra, baboons, and more than 170 bird species.

The Free State has great historical routes, memorial sites, museums, and indigenous villages. The Women's Memorial is located in the province's capital, Bloemfontein, which is also home to the National Museum where you will find one of the most extensive fossil collections in South Africa. Other attractions include the South African War Memorial and New Clare township. Close to the Golden Gate Highlands National Park, the Basotho Cultural Village in Qwaqwa is also a unique experience. To the north of the province, you can marvel at the Vredefort Dome – the world's oldest and largest meteorite impact site, designated a UNESCO World Heritage site in 2005.

Celebrated for its great hospitality and laid-back lifestyle, the Free State is particularly appealing to those interested in exploring small-town South Africa. But there are also plenty of opportunities for hiking, abseiling, and canoeing (among others) for the adventurous at heart. The Ash River is the only river in the country that has high water levels all year round, which makes for excellent white-water rafting.

Bloemfontein is also the judicial capital of the country and home to one of the most unique reserves in the world – a wildlife reserve surrounded by a city. The 250 ha Franklin Game Reserve offers wildlife, including giraffe and wildebeest, and great city views. The Bram Fischer International Airport links this characterful city to South Africa's other major centres.

Considering the province's accessibility, splendour, and affordability, you can hardly imagine a more ideal study destination. But its true beauty lies in its people, who are known to be exceptionally generous and friendly – the perfect home away from home.

Nestled in the hills overlooking the vibrant city of Bloemfontein, lies the South Campus of the University of the Free State (UFS). The facilities can accommodate up to 4 000 students and include lecture rooms, an auditorium, a library, and an impressive administration building.

Our South Campus provides alternative access to higher education for promising students who did not obtain the required marks in their final school examination. Several programmes are in place that offer students the opportunity to access higher education. Through these programmes, students can ultimately enter the mainstream curriculum after completing the preparation courses. By offering this opportunity, students who might otherwise not have been able to enter university, now get to develop their full potential and realise their dreams.

Since its incorporation in 2004, the campus has been playing a significant role in the economy of the region, the enhancement of its people, as well as being a hub for distance-learning programmes offered by the UFS.

### **OFFICE FOR** INTERNATIONAL AFFAIRS

The Office for International Affairs (OIA) serves as the first port of call for all international students at the UFS, providing assistance and specialised administrative support. The principal purpose of the OIA is to enable internationalisation at the UFS. It renders strategic advice on internationalisation and supports the international activities of internal UFS stakeholders. It supports international partnerships, research internationalisation, internationalisation-at-home activities, and student exchanges.

The services include, but are not limited to

- specialised services for international students, and ensuring their compliance with relevant legislation;
- facilitation of international partnerships and advice to internal stakeholders on partnership processes;
- providing practical and emotional support for international students;
- structuring co-curricular internationalisation-at-home activities, such as cultural diversity celebrations;
- supporting co-curricular internationalisation-at-home activities and the social integration of international students; and
- liaison with various external stakeholders, i.e., government, embassies in South Africa, science councils, and funding agencies.

#### WHAT DO YOU NEED TO STUDY AT THE UNIVERSITY OF THE FREE STATE?

#### For degree studies at the University of the Free State, we expect that:

- you have an NSC or NCV with an endorsement that allows entrance to degree studies (bachelor's degree) or an equivalent qualification;
- you meet all the minimum admission requirements for the programme you intend to study. Meeting the minimum admission requirements for your chosen/intended programme of study does not guarantee admission, as limited spaces are available in each programme;
- you have a minimum level of 4 (50%) in English Home Language or English First Additional Language; and
  you must pass certain school subjects with a minimum level of achievement to take certain university modules. For example, you must get a mark of 70% for Mathematics in Grade 12 if you plan to study BSc majoring in Physics with Engineering subjects. Please refer to the section on the faculty-specific admission requirements, which also includes the respective compulsory subjects and achievement levels required per programme.

Proceed through all the steps and submit your electronic application. Make sure that you complete the application form properly, e.g., if you need on-campus residence accommodation or financial aid, indicate this in the relevant section.

#### ALTERNATIVE ACCESS TO HIGHER EDUCATION STUDIES

#### What are the Access Programmes?

We have introduced this programme to assist many deserving students who do not meet our admission requirements. There are various study options:

- Higher Certificate in Economic and Management Sciences (Commerce route)
- Higher Certificate in Economic and Management Sciences (Administration route)
- Higher Certificate in the Humanities (four different options to choose from)
- During your access year, you will get more than just academic information. We address a wider scope of needs to help you prepare for higher-education studies. In the Skills and Competencies in Lifelong Learning course, you will learn skills to help you with problem-solving, self-assertiveness, and other generic competencies. An Academic Literacy course will also improve your academic reading and writing skills.

#### Who may participate in the programme?

It is an open facility that welcomes all applicants who could not obtain access to a higher-education institution, including the University of the Free State.

### **MATRICULATION EXEMPTION**

Matriculation exemption is a legal requirement for first-degree study at a South African university. Students who did not pass the South African Senior Certificate with endorsement are required by law to apply for matriculation exemption from the Matriculation Board. Prospective international students will receive advice on the required type of matriculation exemption. The UFS Office for International Affairs is available to apply on behalf of prospective international students for certificates of conditional exemption if the prospective student so requests.

- You can apply to the University of the Free State before receiving the exemption (USAF) certificate.
- · For applicants currently in Grade 12, or the final year of school, the university may make conditional offers based on final Grade 11 results.

Registered UFS students on the South Campus who have completed the Higher Certificate and wish to continue with bachelor's degree studies, must also follow these steps to apply for a conditional exemption certificate. Students will need to submit final school-leaving results to receive conditional or full exemption.

#### **CHECKLIST FOR REGISTRATION**

Students must be in possession of a valid study visa issued for the UFS. A study visa issued for a different university is not acceptable. No international student will be allowed to register without a valid study visa issued for the UFS.

To cancel the block on your student account, please bring the following documents with you when you register:

- Passport
- Study visa only the actual visa will be accepted no receipts will be accepted for registration purposes
- Confirmation letter for the FULL year from the medical aid registered in South Africa (no travel insurance, hospital plans, or policies will be accepted)
- Proof of payment of registration deposit (for more information on finances, please consult www.ufs.ac.za, then click on fees, for mor detailed information.
- Original documentation as submitted with your application
- USAf-verification

### **IMMIGRATION**

#### **STUDY VISAS**

The university is not permitted to register an international student without producing a VALID study visa, unless the student is studying via distance education from her or his home country. The university must report regularly to the South African Department of Home Affairs on the immigration status of international students. Please note that it can take between six and eight weeks for your study visa application to be processed. Please liaise with the OIA to ascertain changes in immigration requirements during the COVID-19 pandemic.

#### STUDY VISA APPLICATION PROCESS – FIRST-TIME APPLICANTS (NEW STUDENTS)

It is your responsibility to obtain a study visa before arriving in South Africa to commence your studies. During the COVID-19 pandemic, beware of embassy closures, and apply for your study visa as early as possible. Please note that your study visa is issued for study at one institution; you would have to apply for a change of conditions should you wish to change institutions.

You are required to apply for a study visa at the South African high commission, embassy, consulate, or trade mission in your country of residence. If there is no South African representative in that country, you must apply at the nearest South African high commission, embassy, consulate, or trade mission.

The following are the current required documents to be submitted to the South African embassy/ consulate in your country to obtain your study visa: http://www.dha.gov.za/ index.php/types-of-temp-res-permits



- A passport valid for no less than 30 days after intended studies
- Payment of the prescribed administrative fee
- Confirmation and proof of payment for a South African medical aid through a medical scheme registered with the SA Council for Medical Schemes. Coverage must remain valid for the duration of the calendar year
- Letter of offer from the university, stating the duration of the degree
- Undertaking from the university this letter is issued by the Office for International Affairs
- Medical and radiology report not older than six months
- Yellow-fever vaccination certificate, if relevant
- Relevant certificates if married, widowed, divorced, or separated
- Details regarding arranged accommodation while in South Africa
- Proof of sufficient funds to cover tuition fees and maintenance
- A police clearance certificate for the past 12 months.

You are advised to submit the documentation as soon as possible to the South African high commission, embassy, consulate, or trade mission – DO NOT send the documentation to the university. You should keep a copy of your submission and all receipts safe. Please note that it can take longer than one month to obtain a study visa.

#### **REFUGEES/ASYLUM SEEKERS**

Refugees and asylum seekers do not require study visas but need to submit proof from the medical aid (i.e., confirmation letter) that the medical aid is paid for the full year.

#### **PASSPORT RENEWALS**

Passport renewals can be done at the embassy, high commission, or consulate of your home country in South Africa.

#### **LOST/STOLEN PASSPORTS**

If a passport is stolen or lost, the incident must be reported to the police in order to get an affidavit, and also to Campus Control if the passport was lost/stolen on campus. The OIA will then issue the student with a copy of the passport (the page containing your personal details and passport number) and a copy of the study visa. The student should then proceed to his/her embassy to apply for a new passport. As soon as the passport is available, the student should go to: http://www.vfsglobal.com/dha/southafrica/ to apply for a replacement study visa.

#### **CHANGING CONDITIONS OF A STUDY VISA**

A change of conditions usually applies to learners and students studying at South African high schools, colleges, and other academic institutions; their visas would therefore be endorsed with a condition to study at institutions in any of the categories above. In order to register at the University of the Free State, the visa will need to be issued in the name of the university.

Application for change of the conditions of a study visa constitutes a new application for a study visa. Though the applicant will need to complete a separate form, the requirements are the same as for the initial application for a study visa.

#### **ENDORSEMENT OF A RELATIVE VISA**

Please be informed that, with effect from 1 May 2015, a holder of a valid temporary residence visa issued for the categories mentioned below will be allowed to register and undertake part-time studies at institutions of higher learning, as defined by the regulations of the Immigration Act, 2002 (Act No. 13 of 2002), during the validity period of their respective visas.

The holder of a relative visa is still required to get their visa endorsed for part-time studies. The requirements are listed below:

- BI1739 Application for the endorsement of a relative visa
- There is no cost for the endorsement of the visa
- Letter of acceptance/firm offer letter from the university
- Original passport and work permit
- Proof of medical aid
- Proof of finance
- Confirmation of employment letter or contract

#### **WORK PERMITS** FINAL-YEAR STUDENTS – AS PART OF STUDIES (PRACTICALS – MEDICINE, PHYISIOTHERAPY, NURSES, ETC)

 Apply for a waiver of the requirements of the general work permit (https://visa.vfsglobal.com/one-pager/ dha/southafrica/english/index.html#trv-waiver The application must list all that needs to be waived – i.e., advertisement, job offer, etc.

#### • What is a waiver by the Department of Home Affairs?

A waiver application is a formal written request to the DHA to set aside certain prescribed requirements for a visa in any given category. This means that companies and/or individuals may, for a good reason, be exempted from certain prescribed requirements.

How to apply?

To apply for a waiver, the applicant will need to submit relevant supporting documentation for the required visa application and motivate why they need a waiver of the prescribed requirement(s).

 As soon as feedback and approval are received – apply for a general work permit.

### HEALTH AND WELLNESS

#### SOUTH AFRICAN MEDICAL AID

In terms of the Immigration Act 13 of 2002 as amended and its regulations, any prospective student in the Republic of South Africa must provide proof of medical cover with a medical scheme registered in terms of the Medical Schemes Act 131 of 1998. Although you might be able to secure a study visa with other types of medical products, whether South African or otherwise, the University of the Free State only accepts South African medical-aid products. To comply with the regulations, the university requires a membership certificate as proof of full medical-aid cover with a South African-registered medical-aid scheme for the full calendar year, until 31 December of that year.

To avoid unnecessary complications, please make the necessary financial arrangements with the medical-aid provider prior to your entry into South Africa. Should you rely on sponsorship, please ensure that you advise your sponsor of this requirement as soon as you get sponsorship or acceptance. The required medical-aid cover fee must be paid directly to the medicalaid company, separate from the tuition fees. Students will not be allowed to register unless they can show a membership certificate as proof of a valid and comprehensive medical-aid cover for the duration of the academic year (until 31 December);

without a clearance certificate, students cannot register at the institution.

Students who are members or dependents of a South African-based parent/guardian/spousal/work medical aid, are required to present a recent membership certificate for the annual registration. The membership certificate must reflect active membership for the current year.

It is very important to take note of the following academic requirements for junior residences on the:

#### **BLOEMFONTEIN CAMPUS:**

Meeting the minimum admission requirements for your chosen/intended programme of study does not guarantee placement in a residence on campus, as limited space is available in each residence.

- A minimum Grade 12 AP of 30 is required for admission to a residence.
- Your academic merit is determined based on the most recent admission point as calculated by the university (whether Grade 11 or Grade 12 results).
- If you were admitted to a residence based on the Grade 11 AP, but the final Grade 12 AP is less than 30, your admission to a residence will be cancelled.
- If your current AP (Grade 11 final results or Grade 12 June results) is less than 30, you can still apply for residence accommodation. You will qualify for admission to a residence (subject to availability) if your final Grade 12 AP is 30 or more.
- If you are currently in the University Access Programme (UAP), you will qualify for admission to a residence if you pass all your modules.
- If you were registered at the UFS or another tertiary institution for the second or subsequent years, you must have passed at least 120 credits to qualify for admission to a residence. Current first-year students will qualify for admission to a residence based on their Grade 12 AP.

#### SOUTH CAMPUS:

Admission to a full-time programme on the South Campus: If you were provisionally admitted to a residence on the Bloemfontein Campus prior to your final Grade 12 results becoming available and your final results indicate that your studies encompass an extended curriculum programme on the South Campus, such provisional admission shall automatically be transferred to a residence on the South Campus.

Your admission is in all cases subject to you meeting the conditions pertaining to the aforementioned admission.



As a prospective student, you must keep in mind that placement in a residence does not mean that you have been selected for a particular field of study. In order to be considered for placement in a residence, you must have received either a conditional admission offer for a programme of study or a final and firm offer for admission.

The final Grade 12 marks will eventually determine whether you qualify for admission to an undergraduate programme of study and residence accommodation. You will only be allowed to occupy the residence in which you have been placed once you register as a student.



Some residences have communal kitchens, although students could also make use of two dining halls offering three meals per day on a meal-account payment system, or a variety of cafeterias.

#### ACCREDITED OFF-CAMPUS ACCOMMODATION

### **FAQs & ANSWERS** ON REGISTRATION OF AN INTERNATIONAL STUDENT

#### I have refugee and/or asylum seeker status in South Africa. What should I do to have it reflected on the system?

A student's fee status is based on their citizenship/residence at the point of registration. If a student presents original certified documented proof of alternate citizenship or residency before 31 July, the residency and associated fee status will be amended for that academic year. The following documents will be accepted as proof:

- A South African identity card/book
- A refugee or asylum seeker permit issued by the South African Department of Home Affairs

Only certified copies of the original document can be accepted. Documents can be certified at a police station, or by a notary public.

Changes in citizenship status submitted before 31 July will be used to recalculate your tuition fee liability for the current academic year. Citizenship/residency status changes presented after 31 July will only be applied to the fee status for the following academic year.

Your fee liability for the current academic year will only be adjusted once your residency status has been evaluated and changed in the student records and administration system (PeopleSoft).

To notify us of a change in your residency status, please submit a certified copy of your permanent residence permit to niemannaja@ufs.ac.za

#### I have received permanent residency status in South Africa. What should I do to have it updated on the system?

A student's fee status is based on their citizenship/residence at the point of registration. If a student presents original certified documented proof of alternate citizenship or residency before 31 July, the residency and associated fee status will be amended for that academic year. The following documents will be accepted as proof:

- A South African identity card/book
- A permanent residence permit issued by the South African Department of Home Affairs

Only certified copies of the original document can be accepted. Documents can be certified by a commissioner of oaths, at a police station, or by a notary public.

Changes in citizenship status submitted before 31 July will be used to recalculate your tuition fee liability for the current academic year. Citizenship/residency status changes presented after 31 July will only be applied to the fee status for the following academic year.

Your fee liability for the current academic year will only be adjusted once your residency status has been evaluated and changed in the student records and administration system (PeopleSoft).

To notify us of a change in your residency status, please submit a certified copy of your permanent residence permit to niemannaja@ufs.ac.za

#### Why do I have to submit my documentation before registration at the UFS?

The administrative process is to verify and capture immigration documentation and proof of initial fee payments for international students and researchers prior to their registration at the UFS. The Immigration Act requires all institutions of higher learning in South Africa to keep a record

of international students registered at their institution. A report on international student registration is submitted annually by the UFS to the South African Department of Home Affairs.

The UFS is required to complete this process to comply with government regulations to ensure that each international student has valid immigration documents for the duration of their registration.

#### What documents do I need to register as a full-time student?

Immigration documents if you are studying in person and have a visa endorsed for study at the UFS.

- Certified copy of passport bio page
- Certified copy of relevant visa endorsed for the UFS (i.e. study) visa, endorsed for study at the UFS or visitors' visa endorsed for research)
- Medical aid confirmation from a registered South African medical aid scheme, valid for the full duration of the visa and NOTE:

All immigration documents to be certified by a commissioner of oaths or a notary. The certification stamp must include the name of the commissioner of oaths, their designation and signature, the date, and wording along the lines of 'the following documentation is a true and accurate reflection of the original'. The certification stamp cannot be more than six months old at the time that the documents are submitted for preregistration.

For those who hold refugee, asylum seeker, permanent residence status or citizenship for South Africa, we will only accept certified copies of these documents; no passport bio page and proof of medical aid is required; however, if it is submitted the information will be captured.

#### What documents do I need to register as a part time/online/ distance student?

- Certified copy of passport bio page
- Confirmation letter or email from faculty/department that you will be doing your studies part time/online/distance and will not be in South Africa on a full-time basis during your studies. (niemannaja@ufs.ac.za / tshabalalal@ufs.ac.za)

#### Why do I need South African medical aid?

The South African Immigration Act requires that all international students purchase medical aid cover from a medical aid scheme registered with the South African Council of Medical Aid Schemes before applying for a study visa. The cover must be for one year (renewable annually) or for the full duration of the study programme and intended stay in South Africa if this is shorter than one year.

As part of registration, the International Office is required to confirm that you meet the visa conditions for entry to South Africa and registration as a student at the UFS.

You will not be permitted to register unless you have the correct medical aid cover.

#### I have accepted the offer made to me and need to apply for a study visa; what should I do?

As soon as you have been accepted/conditionally accepted as a student at the UFS, you will have to contact the Office for International Affairs at the UFS to request an undertaking letter to assist you in applying for a study visa.
